Notice is hereby given that the City of Kirkland will receive sealed bids in the office of the Purchasing Agent, City Hall, 123 Fifth Avenue, Kirkland, Washington, at 2:00 PM local time on May 22, 2018, for the project hereinafter referred to as:

### **124th Avenue NE Sidewalk Improvements JOB NO. 17-17-PW**

At said time all bids will be opened and publicly read aloud. Each bid shall be accompanied by a bid proposal deposit in the form of a cashier's check or a bond issued on a form acceptable to your surety made payable to the City of Kirkland for a sum of not less than five percent (5%) of the total bid amount. No bid shall be considered unless accompanied by such bid proposal deposit. Incomplete proposals and proposals received after the time stated above will not be considered. Faxed or emailed responses are not acceptable.

- The work to be performed under these specifications consists of furnishing all labor, tools, materials, and equipment necessary for construction of the 124th Avenue NE Sidewalk Improvements. Specific work includes, but is not limited to, concrete curb, gutter, sidewalk, pervious concrete sidewalk, elevated walkway structure, ADA curb ramps, water service lines, storm drainage pipe and structures, retaining walls, driveway approaches and asphalt driveways, channelization striping, landscaping, and property restoration and miscellaneous work. The estimated cost for this project is in a range of \$1,300,000 to \$1,400,000.
