Subject: LAKEVIEW NEIGHBORHOOD PLAN UPDATE-ADVISORY GROUP

RECOMMENDATION

That the Houghton Community Council either:

1. Appoint members to the Lakeview Advisory Group (*depending how many additional emails or letters we receive from people interested in being on the Advisory Group between now and December 14, meeting*), or
2. Provide direction to staff on an alternative planning process that does not include an Advisory Group.

BACKGROUND DISCUSSION

The Houghton Community Council and Planning Commission agreed to the formation of Advisory Groups to work with staff to update the Lakeview and Central Houghton Neighborhood Plans. The Advisory Groups would be comprised of neighborhood association chairs, representatives from Boards and Commissions, approximately 5 residents and 5 businesses located in the neighborhood and city staff. Membership for the Central Houghton Advisory Group was approved at the November 23, 2009 meeting.

To have a diversified and balanced group it would be ideal to have more residents and businesses on the Advisory Group. Because of the lack of response from residents and businesses in the Lakeview

neighborhood you recommended extending the deadline for letters of interest to the December 14, 2009 meeting and that the Council would help staff recruit for members.

Staff has recruited for the Advisory Groups using the following methods:

- Two articles in the Kirkland Courier newspaper
- Emailed the October 29, 2009 Open House attendees
- Advertised on the City and Planning Department WebPages
- Sent out announcements to both project and citywide list serves
- Emailed several requests to the Lakeview Neighborhood Association
- Mailed letters (21) to parties of record mailing lists from past zoning permit applications and Shoreline Master Program update
- The Economic Development Manager contacted several business owners

Alternative Planning Process Approach

If it is determined that there will not be an advisory group because of lack of interest, the Houghton Community Council should discuss an alternative public participation process. One option could be to hold a neighborhood workshop on key issues for all Lakeview residents and interested parties. Then staff would take the initial step of updating a draft of the plan and working through key policy issues with the Houghton Community Council at study sessions. Before the public hearing a second public open house or workshop could be held to inform the public of the proposed draft plan and code amendments. Please provide direction to staff on which way to proceed.

As a reminder staff is hosting a "Neighborhood U" on December 8th and December 9th, 7:00-8:30 pm in the Peter Kirk Room at City Hall. For background we will give an overview "Planning 101" and why we have the Comprehensive Plan. The focus of the two day event will be an interactive community dialogue on how we can improve the Neighborhood Plan process in Kirkland. We will be using some unique public participation techniques to make it fun. Everyone is welcome to attend. Hello Janice,

I am writing to submit my application for the Lakeview Neighborhood Advisory Group.

My husband and I have been residents of this area since 1980. We built our home on Lake Washington Blvd. and have enjoyed living her for the past 30 years. Over the past two years I have had a few conversations with Eric Shields about updating the neighborhood plan. My immediate concern is the deteriorating condition on the Blvd from 38th to about 48th.

The Blvd is the gateway into Kirkland for most people. But the condition from Northup Way north is not very inviting. Aside from the few commercial buildings, the residential areas look sadly unkempt. The housing is at least 50 (or more) years old with little or no renovation, the lawns and trees are overgrown and the lawns often not mown. Several of the homes are now rental, something that continues the downward slide of a neighborhood. This is certainly not the way we want the entrance to our City to look and gives the cars and passengers a negative impression of this beautiful city.

To change this current situation will require a new neighborhood vision statement, along with goals and policies to bring that vision to reality. It may also require some updated zoning code amendments that will bring the existing larger lots into compliance with the State Growth Management Act. Kirkland has a wonderful natural environment with Lake Washington running the entire length of the city. We need to build on this natural beauty and take advantage of what it offers us.

Residents also face difficulty crossing the Blvd. as there are no traffic lights between 38th and Carillon Point. The two or three crosswalks are hazardous because traffic moving at 35 miles per hour and often more. This is another issue that the Group could be addressing.

Another issue, related to this one, is the state of the eastern sidewalk along the Blvd. In many areas, the sidewalk is cluttered with leaves, branches, overgrown weed berry vines and trees, sometimes marking it almost impossible to walk on this side. Some new housing stock will help rectify this situation, but it may also be necessary to have the city enforce some of the rules governing sidewalk clearance, and also require a citizens group to work with residents in the area to ensure the Blvd looks neat and tidy at all times.

I believe my commitment to this part of Kirkland is evident in my four years as an elected member of the Houghton Council. I look forward to working with the Advisory Group to bring new life to this part of Kirkland, as well as the rest of the Lakeview Neighborhood area, to make our area of the city an outstanding gateway.
