4500 LAKE WASHINGTON BOULEVARD SHORT PLAT

CASE NO. [SUB14-00880](#) & [SHR14-01156](#)

PROPOSAL: Moira Haughian of The Blueline Group, the applicant, is requesting a Process I Short Plat Permit and Substantial Development Permit to subdivide one 21,227 square foot parcel into two parcels of 8,402 and 12,825 square feet in the PLA 3C Zone. The existing house will be retained. Property located within Shoreline Jurisdiction (see SHR14-01156). The application was received by the City on June 24, 2014 and was deemed complete on July 16, 2014.

LOCATION: [4500 Lake Washington Boulevard NE](#), located within the SW quarter of Section 17 of Township 25 N., Range 5 E.W.M., in Kirkland, King County Washington.

NEIGHBORHOOD: Lakeview

REVIEW PROCESS: The decision on this application will be made by the Planning Director. Prior to the decision, there is an opportunity for the public to submit written comments, as described below. The Director will also receive a report from the Planning Department staff making a recommendation on the application. The decision will be based on whether the application complies with Kirkland's Subdivision Code, Shoreline Master Program and other applicable codes.

PUBLIC COMMENT: Comments may be provided in writing only. **To be considered, written comments must be received prior to 5 p.m. on October 7, 2014.
