### CITY OF KIRKLAND NOTICE OF APPLICATION DOCKSTADER-PETTIT SHORT PLAT, CASE NO. [SUB16-01383](#)

**PROPOSAL:** Craig Krueger, the applicant, is requesting a Process I Short Plat Permit to divide two parcels totaling 44,186 SF into six individual parcels and provide public right-of-way dedication in the RSX 7.2 Zone using the Small Lot Single-Family provisions of KMC 22.28.042. The application was received by the City on July 8, 2016 and was deemed complete on July 25, 2016.

**REVIEW PROCESS:** The decision on this application will be made by the Planning Director. Prior to the decision, there is an opportunity for the public to submit written comments, as described below. The decision will be based on whether the application complies with Kirkland's Zoning Code and other applicable codes.
