### CITY OF KIRKLAND NOTICE OF APPLICATION LEVINSON SHORT PLAT, CASE NO. [SUB14-01565](#)

**PROPOSAL:** John Rubenkönig, the applicant, is requesting a Process I Short Plat Permit to subdivide one 17,499 square foot parcel into two parcels of 6,749 and 10,750 square feet in the RS 7.2 zone. The existing house and carport will remain. The application was received by the City on August 25, 2014 and was deemed complete on September 17, 2014.

**REVIEW PROCESS:** The decision on this application will be made by the Planning Director.
