**NOTICE OF APPLICATION**  
**ZHANG SHORT PLAT, CASE NO. [SUB16-01244](#)**

**PROPOSAL:** Qian Zhang, the applicant, is requesting a Process IIA Short Plat Permit to approve a three-lot short plat with wetland buffer modification. The application was received by the City on May 26, 2016 and was deemed complete on July 20, 2016.

**NEIGHBORHOOD:** North Rose Hill

**REVIEW PROCESS:** The decision on this application will be made by the City's Hearing Examiner. The process involves an opportunity for public comment in writing or at a public hearing to be held by the Hearing Examiner. Prior to the hearing, the Planning and Building Department will prepare a staff report making a recommendation on the application. Following the hearing, the Hearing Examiner will make a decision to approve, modify or deny the application. The decision will be based on whether the application complies with Kirkland's Zoning Code and other applicable codes. **A hearing date has not yet been set. Notice of the hearing will be given at least 14 days before the hearing.**

**PUBLIC COMMENT:** Written comments received prior to 5 p.m. on August 16, 2016 will be considered by the Planning and Building Department in preparing its recommendation and staff report to the Hearing Examiner. Written comments may be submitted to the Hearing Examiner at any time before the close of the public hearing. Oral comments may be provided at the hearing. Those who provide written or oral comments before the close of the public hearing, will receive a copy of the Hearing Examiner's decision for a Process IIA short plat permit.
