*Thank you in advance for your patience and cooperation as we make improvements to your neighborhood.*

**What:** Replace existing watermain along 120<sup>th</sup> Avenue NE in the South Rose Hill Neighborhood. The watermain runs along the west side of 120<sup>th</sup> Avenue NE, beginning at NE 70<sup>th</sup> Street, heading south, extending just beyond the end of the cul de sac (see map on back).

The existing watermain is 6" diameter asbestos cement pipe that is nearly 50 years old. This will be replaced with 8" diameter ductile iron watermain. The project includes full reconstruction and resurfacing of approximately 400 feet of 120<sup>th</sup> Avenue NE.

**When:** Contractor bids will be received in January 2013 and construction is expected to begin in March 2013.

**What to Expect:**

A Project Update with more information will be mailed after the contractor has been selected and the construction schedule has been confirmed.


