Four questions were received regarding this Request for Proposals by the question submittal deadline of 5:00 p.m. on March 17, 2014. Following are the questions and the City's responses:

1. Will COK want to have a Co-Pay for their members to use the new onsite clinic or will they want it to be free to their members?

Response: Free.

2. Are there any LEOFF 1 employees included in the number of current subscribers?

Response: Yes.

3. Are we able to mark certain sections of our responses confidential?

Response: The RFP Response is subject to public disclosure laws. If your proposal is requested by an outside party you will be notified and allowed two weeks to obtain a court order to prohibit us from releasing the records if we believe the records do have to be disclosed.

4. Are we able to get a zip code file of employees/dependents? No other data is required

Response: Yes (see attached).

5. I noticed that in section III of the PSA titled "Termination of Agreement" it states that the city or consultant may terminate this agreement with or without cause, by giving ten (10) days written notice. Is this section able to be adjusted by removing the phrase "WITHOUT CAUSE" or if the provider includes performance guarantees?

Response: There is some flexibility on this, but we would like to see a date or days attached. The City of Kirkland's legal department will have final say.
