Item 2:

Location: Bid Schedule. Bid Item 4: Minor Change/Force Account
Description: Add \$15,000 in the Unit Cost column.

Item 3:

Location: Bid Schedule. Bid Item 39: Resolution of Utility Conflicts
Description: Add \$15,000 in the Unit Cost column.

Item 4:

Location: Special Provisions 1.02.14-8A.b

Description: Delete paragraph 1.02.14-8A.b and replace with the following paragraph:
"Bidder shall have completed a minimum of two fish passable culvert projects, at least 10 feet wide for a fish bearing stream for a public agency."

Item 5:


Location: Special Provisions 1.02.14-8B

Description: Delete the first sentence only in paragraph 1.02.14-8B and replace with the following sentences:

"Documentation: The Bidder shall submit documentation of public works projects completed within the previous three (3) years. For culvert projects listed in paragraph 8A.b above only, the Bidder may add documentation for projects completed within the previous 10 years."

The remainder of paragraph 1.02.14-8B is not revised.
