Subject: No to off-leash dog park in Heritage Park!

I am writing to express my strong opposition to the off-leash dog park in Heritage Park, even if the area is only temporary.

First, Heritage Park sits directly across from homes, with homeowners who enjoy the quiet nature of the neighborhood. Adding an off-leash dog park directly across from people's houses just doesn't make sense.

Second, the 100 block of Waverly Way already suffers from parking challenges during the warmer months. Adding an off-leash dog park further exacerbates this problem.

In contrast, the Jasper Dog Park is, in my view, an example of good location selection for an off-leash dog park as it is not located directly across from homes. Marymoor Park in Redmond is another example of an appropriate location for an off-leash dog park far from people's homes.

Please include my email as correspondence in the next Parks Board written materials, and share with any appropriate stakeholders within the City involved in selecting locations for off-leash dog parks, either temporary or permanent.
