



# CITY OF KIRKLAND NOTICE OF APPLICATION KIRKLAND SHORT PLAT, CASE NO. SUB22-00367

**PROPOSAL:** Larry Scrivanich, the applicant, is requesting a Process I Short Plat Permit to divide the existing 19,050 SF lot into two lots after ROW dedication. Lot 1 = 10,340 SF; Lot 2 = 7,757 SF; ROW dedication = 953 SF. The application was received by the City on May 20, 2022 and was deemed complete on July 6, 2022.

**NEIGHBORHOOD:** Juanita


**REVIEW PROCESS:** The decision on this application will be made by the Planning Director. Prior to the decision, there is an opportunity for the public to submit written comments, as described below. The Director will also receive a report from the Planning and Building Department staff making a recommendation on the application. The decision will be based on whether the application complies with Kirkland's Zoning Code and other applicable codes.

**PUBLIC COMMENT:** Comments may be provided in writing only. **To be considered, written comments must be received prior to 5:00 p.m. on August 01, 2022.** Send written comments to project planner, Peter Milliken, 123 5th Avenue, Kirkland, WA 98033 or to e-mail pmilliken@kirklandwa.gov. Please indicate your name, mailing address, e-mail address and refer to permit number SUB22-00367. A copy of the Director's decision will be mailed to those providing written comments before the comment deadline. Others may obtain copies from the Planning and Building Department.

**APPEALS:** The Planning Director's decision may be appealed to the Hearing Examiner only by the applicant or those who submitted written comments by the comment deadline. Additional information about how to appeal will appear in the staff report and Planning Director's decision.
