i. Revised Code of Washington (RCW 42.56) Public Records Act requires public access to all records and materials from state and local agencies. City provides boards/commission members with a COK email address to make for ease of responding to public record's requests. Best practice to keep email exchange to the topic under discussion.

- c. Open Public Meetings Act
  - i. Revised Code of Washington (RCW 42.30) Public Meetings Act requires that agency meetings be declared open and public. Date/Time are publicized so that the public can plan to attend if interested. Definition of meeting is a gathering of the board/committee members with a quorum to take action. Best practice to avoid email communication with 'reply all' discussion as this could constitute a meeting. The topic and discussion and any decisions need to be made at a public meeting.
