  - i. 1% on construction projects given to KCAC for art project.
  - ii. 4Culture Grant
    - a) Currently used for Park Lane Outdoor Gallery 1yr exhibit cycle
      - i) Consider change to a 2-year cycle
        - Pros: less overhead cost (PW, signage), less staff time, longer exhibit visibility for artists.
        - Cons: art could grow stagnant for public
        - Considerations: Have backlog of artists in case one of the current exhibits sells and need alternate to fill in. Cost of that additional stipend to alternate artist or leave plinth vacant. Could not implement with current exhibit. Would need to make change in a future art call.
    - b) 2023/2024 4Culture Grant Program.

Write the grant to sustain current Park Lane Gallery program but have it flexible to use grant money for other one-time projects during the grant cycle. i.e. Frog on CKC.

- c. Artist Long Gao (Spring Song 2021-2022 Park Lane Exhibit) would like to donate several sculptures to the City.

#### **Donations and Loans**

As mentioned above, the presumptive and preferred acquisition method for public art is the *commission* of art for site specific locations, and *not donations*. Where donations of public art are proposed, including proposed donated memorial art, *the City prefers to receive unrestricted monetary donations* to support the commission of art rather than donations of physical art in order to ensure alignment with current criteria and priorities for public art in the City, and to preserve stewardship over the appropriate use of public space. Unrestricted monetary donations to help fund public art acquisitions will be accepted at any time.
