5. DISCUSSION

- a. KPCF Art Donation Proposal KCAC committee met:
 - i. Proposed piece doesn't meet the guidelines of the KCAC's goal to accept temporary donated art rather than permanent donated art.
 - ii. Proposed art may be too similar to other works of art currently in place at the proposed waterfront sites and the preference is to have more of a variety.
 - iii. The City's Park Board along with KCAC should be involved in selection process to ensure that the selected art is consistent with that board's vision for Kirkland parks.

KCAC will vote in February on this donation proposal.

b. CIP 1% Arts Update for 2023-24 Staff updated:

1% arts group meets February 2, 2023 to review the preliminary list of capital projects. Expect to receive a list of projects involving the KCAC after this meeting. Potential projects include:

i. Safer Routes to School (aka Stores to Shores)

ii. Multiple Transportation Benefit District (TBD) projects that could all be bundled into one larger art project.

e. Lake Street Pedestrian Scramble Medallions – PW CIP Staff and Contractor KPG

Craig Martin – City staff CIP coordinator, and Holly Williams and Erick Olson with consulting firm KPG who is designing the pedestrian scramble.

Overview: intersection of Kirkland Ave and Lake St. Scramble crossing means all crosswalks active at same time with no traffic while pedestrians have right-of-way. Medallions not considered a 1% of the arts so KCAC will not be involved in the selection of artist. However, KPG is sharing the working design tonight with the KCAC.

History of design proposal: Bronze plaques on the sidewalk corners with a theme representing the Kirkland waterfront history of ferries that had ties to Kirkland, either built in Kirkland or provided transportation on the lake.

KCAC feedback: The presented photos of the initial ferry design draws attention to the smoke coming out of the stack and looks more like pollution than possibly the image the artist is trying to portray.

Staff and KPG invited KCAC to submit any additional comments or observations to Martha Chaudhry and she will pass them on to the consultant.
