4. ADOPTION OF MINUTES

a. June 18, 2025, Regular Meeting Minutes

a. Park Lane Outdoor Sculpture Gallery Update - Alisa Sargsyan

Government Affairs Manager Diana Hart updated the Commission that the Low Clearance Bridge Mural Project is being extended into 2026. Chair Sargsyan confirmed Luana as the chair of the Low Clearance Bridge Mural Project Subcommittee.

d. Support Infrastructure Committee Update - Prashant Walia

Vice Chair Walia updated the Commission on the Art Desert Project, including timeline, including Council, and installing plinths.

e. Kirkland Community Foundation Sculpture Donation Subcommittee - Mike Potter

Government Affairs Manager Diana Hart verified for the Commission that the current donation policy would allow for the acceptance of this sculpture provided that the Commission makes the recommendation to the Council to accept it.
