d. Revised Public Art Policy and Guidelines, presented by Jim Lopez

Assistant City Manager Jim Lopez presented an overview of the revised Kirkland Public Art Policy and Guidelines which have been modified to establish a clear connection to Resolution R-5434, provide enhanced clarity about different types of public art, and create a structure to guide the placement of public art in the City of Kirkland.

(1) Revised Kirkland Public Art Policy and Guidelines

Motion made by Vice Chair MacLean to embrace the modifications to the art selection guidelines additionally recommending that we add a little bit of language about signage. The motion was seconded by Commission Laurant.

An amendment was made to the motion to replace the phrase "art selection guidelines" with "Public Art Policy Guidelines." The amendment to the motion carried unanimously, 8-0.

The motion as amended carried unanimously, 8-0.

Assistant City Manager Lopez informed the KCAC that Kellie Stickney is no longer with the City.

Chris Hendrickson gave a brief update on the new City of Kirkland website on which the KCAC has its own commission page plus two general art pages.

Commissioner Thompson gave an update on efforts to acquire art for the Park Lane Outdoor Sculpture Gallery.

(4) North and South Rose Hill Greenways Project, committee: Chair Nunnelly, Vice Chair MacLean, and Commissioner Young

Chair Nunnelly gave an update on the progress of the art slated for the North and South Rose Hill Greenways Project.

g. KCAC Vacancies

Chairperson Nunnelly invited KCAC to contemplate reducing the size of the commission from 13 members to 11 members. This item will be discussed at an upcoming KCAC meeting.
