North Eastside Mobility Project (NEMP) Outreach

- Outreach conducted over three phases in 2018
- Sounding board comprised of community members
- CBOs helped us reach immigrant and low-English speakers
- More than 10,000 people informed about project
- 3,000+ members of the public Had a Say

Status of NEMP

- King County Council expected to take action this summer
- March 2020 implementation
- Transit agencies creating rider support plan

- Is the "Best of Metro"
- Has high quality service and facilities
- Employs state-of-the-art innovations
- Travels natural transportation corridors
- Has the highest level of speed and reliability investments among Metro services





Corridor 1013	Seattle/Eastlake/University District (Roosevelt)	Spring 2024
Corridor 1071	Seattle/Mount Baker/Rainier Beach (Rainier)	Fall 2024
Corridor 1027	Totem Lake/Bellevue/Eastgate	Spring 2025

RapidRide 1027 Capital Improvements

~\$90M expected capital investment

- Speed and reliability
- Passenger facilities (new kit of parts under development)
- Communications and technology
- Access to transit



RapidRide 1027 Alignment

- Representative alignment:
 - Identified in METRO CONNECTS
 - Totem Lake to Eastgate
 - Portions of Routes 234, 235, 255, 271
- Based on NEMP input, Metro is now considering an alternative endpoint to Downtown Redmond instead of Totem Lake
- After the endpoint is determined, exact street routing will be considered during Phase 1 of the project

Project Schedule

- Consultant scoping underway
- Kick-off Summer 2019
- Applying for FTA Small Starts Funding in 2020
- Expected revenue service start in 2025
