Comments from Commissioners: How can we support alternate modes of transportation as people return to commutes, while they may not be comfortable with transit, attempting to mitigate the effects on the transportation system; status of the closure of Park Lane to vehicles and the possibility of making it permanent; requested posting the slides from the NE 85th Street Station Area Plan on the Commission website. It was noted that the NE 85th Street Station Area Plan has a dedicated website; leafline Trails Coalition upcoming meeting; Bike Summit is free this year, online, spread out for the week; Eastrail has a new permanent section along the Sound Transit station in Bellevue; REI has sold their building to Facebook, and each business will donate \$1,000,000 to Eastrail; K-line not funded in KC Metro budget, currently on pause by Metro; bring back snapshot of recent transit changes to a near future meeting.
