# Proposed KMC Modification

## **3.45.040 Powers and duties of commission**

The commission is directed by the city council to advise the public works department, city manager, and city council in leading the city's efforts to create and maintain a transportation system that enhances the economic, social, and environmental quality of life in our city now and into the future. To fulfill its mission, the commission will work with the public works department to establish a two-year ~~an annual~~ work plan which proactively explores, investigates, analyzes, prioritizes, develops, and recommends solutions and actions to the city manager and city council. The city council and commission will meet at least once every two years ~~annually~~ to discuss the two-year ~~annual~~ work plan for adoption by council. (Ord. 4531 § 1, 2016: Ord. 3846 § 1 (part), 2002)
