5. NEIGHBORHOOD SAFETY PROGRAM (0:03)

A presentation on the Neighborhood Safety Program and 2025 recommended projects was provided by Senior Community Engagement Coordinator and NSP program lead, Daniel Lazo, and technical reviewer Transportation Planner Victoria Kovacs. Commissioners asked questions on program funding, cost adjustments, specific project details, technical assistance, and the overall process. Feedback for the NSP program was focused on what other programs exist to fund projects as well as what the process is for remembering unfunded projects for future consideration.

6. TRANSIT NEEDS STUDY (0:37)

The Transportation Commission and Staff discussed outcomes and scoping for the upcoming Transit Needs Study. The Transportation Commission recommended the study identify an unconstrained network vision for transit that is aligned with the city's adopted land use vision, and engage not just residents but the broader traveling community of workers and visitors in

Kirkland in order to identify community barriers to taking transit to have a broader understanding of transit needs. Barriers may not just be origin/destination, but also schedules, transfers, walking access, information access, and the overall quality of the transit experience.
