## ORDINANCE O-4740

## AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO LAND SURFACE MODIFICATION AND AMENDING SECTION 29.12.010 OF THE KIRKLAND MUNICIPAL CODE.

WHEREAS, KMC 29.12.010 sets forth exemptions from Land
 Surface Modification permits and utilities or other work in a right-of-way
 supervised by the City as authorized in writing by the director of the
 department of public works; and

WHEREAS, said exemption does not apply to work in a right-ofway located in critical areas and their buffers; and

WHEREAS, although geologically hazardous areas are included
in the definition of critical areas, the City has not historically required
permits for such work in geologically hazardous areas in the right-ofway because land surface modification permits duplicate the project
engineering and inspection functions as overseen by the director of the
department of public works; and

WHEREAS, pursuant to the State Environmental Policy Act (SEPA), there has accompanied the legislative proposal a SEPA Addendum to Existing Environmental Documents issued by the responsible official pursuant to WAC 197-11-625; and

WHEREAS, in public meeting the City Council considered the environmental documents received from the responsible official.

NOW, THEREFORE, the City Council of the City of Kirkland do
 ordain as follows:

27 <u>Section 1</u>. Kirkland Municipal Code Section 29.12.010 is
 amended to read as follows:

Except in (1) critical areas and their buffers, (2) areas waterward of the ordinary high water mark (OHWM), (3) shoreline setback, or (4) areas with an historic overlay designation, a land surface modification permit shall not be required for the following:

(a) The removal of overhanging vegetation and fire hazards as
 specified in Section 21.41.302 of the Kirkland Municipal Code.

37 (b) The removal of prohibited vegetation.

(c) Land surface modification performed in the normal course of
 maintaining existing landscaping on a lot associated with an existing
 building or buildings, provided such work:

(1) Does not substantially change the points where the stormwater
or groundwater enters or exits the subject property; and will not
change the quality, quantity, or velocity of stormwater or groundwater;
(2) Does not result in an increase or decrease in topography at any
point of more than four feet; and

(3) Does not involve more than fifty cubic yards of material in any 46 47 twelve-month period. (d) Any excavation authorized by a valid building permit. This shall 48 not exempt any fill made with the material from such excavation when 49 the material is removed from the lot or any fill material which is placed 50 51 on the lot. 52 Utilities or other work in a right-of-way supervised by the city of (e) Kirkland, authorized in writing by the director of the department of 53 public works, or as allowed by a right-of-way permit approved under 54 Chapter 19.12 of the Kirkland Municipal Code. Geologically hazardous 55 areas shall not preclude this exemption. 56 57 (f) Excavations for franchise utility service connections (power, telephone, cable, gas, etc.) to serve existing and/or new structures. 58 Correction of storm drainage problems when supervised by the 59 (q) department of public works. 60 Exploratory excavations under the direction of a professional 61 (h) engineer licensed in the state of Washington, as long as the extent of 62 the land surface modification does not exceed the minimum necessary 63 64 to obtain the desired information. Normal maintenance and repair of the facilities of a common 65 (i) 66 carrier by rail in interstate commerce within its existing right-of-way. Cemetery graves. 67 (i) 68 Section 2. If any provision of this ordinance or its application to 69 any person or circumstance is held invalid, the remainder of the 70 ordinance or the application of the provision to other persons or 71 circumstances is not affected. 72 73 Section 3.
