The purpose of this project is to provide safety improvements to the intersection of 108th Ave NE & NE 137th PI which is at the main entrance to Edith Moulton Park. As a result of this project, safety will be enhanced and access to the park will be improved through measures that will encourage lower vehicular speeds along 108th, a cut-thru street for many drivers, which are often exceeding the 25 mph speed limit traveling at speeds over 35 mph.

Proposed improvements are depicted on the attached figure:

- New marked crosswalks (2)
- SW corner improvements to modify this location to expand and upgrade the pedestrian space with tactile edge lines and/or flex posts and include curb ramp improvements
- NW corner improvements to provide an ADA ramp and smooth asphalt paving between ramp and crosswalk
- The potential for an adjustment of an existing light or installing a new light is being evaluated by the City and PSE and will be included if required to ensure the crosswalks are well-lit
- Types of treatments used will be adjusted as needed to stay under the \$50,000 funding limit

1. Neighborhood Benefit/Support (0–60 points)

Please explain how the project will address a recognized safety need (especially with school kids or other vulnerable populations) and result in a positive and lasting neighborhood benefit (e.g., creates an important neighborhood pedestrian or bicycle connection):

The need for this project has long been identified within the neighborhood. 108th Avenue NE is a street within Juanita that collects a lot of traffic flow from the nearby area and also those from outside Kirkland who use the street as a cut-thru route. Edith Moulton Park (at NE 137th PI) and Helen Keller Elementary (at NE 140th St) are both located on this street. Further, 108th Avenue NE is a school walk route for both Helen Keller Elementary and nearby Juanita High School. This street is also identified in the Kirkland Transportation Master Plan to be a recommended greenway. Within the Kirkland Neighborhood Greenways Guide for Implementation, this is listed as the 'Juanita HS' and of the 14 projects this corridor tied with others for the 2nd highest score in categories of 'Connects Destinations' and 'Improves Safety'.

Beyond the current needs already identified through these sources, members of our neighborhood understand that WSDOT's project (https://www.wsdot.wa.gov/Projects/I405/NE132ndStInterchange/Default.htm) to construct a new interchange at I-405 and NE 132nd St will increase traffic along this corridor with construction on that project starting in 2021 (this year) and completion in 2024. As this NSP cycle will complete improvements by June 2022, we believe this is an appropriate time to provide needed improvements to address immediate safety concerns as well as helping to address future concerns.

When this project option was presented to the Juanita Neighborhood Assocition for the 2019-2020 NSP cycle in November 2019 amongst a group of project options, there was unanimous support from all neighborhood members (25 in attendance) for this project to be the top neighborhood priority.

In addition to sharing this project at that November 2019 meeting, by email, and on the JNA website, outreach was done to the principal and PTA for nearby Helen Keller Elementary given that the school is 1 block away from the improvement location and 108th Ave NE is part of the local school walk route.

Outreach to immediate neighbors above and beyond current neighborhood communications, such as modifications for streetlights at the crosswalks, was not conducted. All improvements would be done within City right of way and in the current roadway footprint. Potential modifications to adjust the lighting to ensure the crosswalks are well lit would not be evaluated until project funding is obtained and design is under way.

As noted above, this project as widespread support within the immediate portion of the neighborhood. For benefit of the community beyond the neighborhood, this project stands to benefit all users of Edith Moulton Park. As Edith Moulton is the largest park in North Juanita (and was recently improved), it has become a destination for many residents. The ability to enhance the entrance to the park and provide a safer access for these users will be a wonderful benefit to the greater community.

During the Fall 2019 Welcome to Juanita event at Edith Moulton Park, our yearly picnic in non-pandemic times, the possibility of intersection improvements were discussed with attendees from the immediate neighborhood area and and beyond. Each person fully supported improvements and several even questioned why at least one crosswalk wasn't installed as part of the recent park improvement project!
