

### Funding

• Staff are combining 2023 funding with 2022 funding for a total budget of \$700,000.

• The total projected cost of the recommended 2022/2023 projects is \$632,000. Staff is recommending that the difference between the funding amount of \$700,000 and the projected expenditures of \$632,000 be retained for contingency.

#### Practices to Limit Cost Increases


- 1. Develop the scope of work for the improvements as early as possible.
- 2. Strategically package projects.
- 3. Complete design, acquisition, permitting, and construction in the shortest time possible.

### Sustainability Practices

All projects are guided by two key strategic points:

The life cycle of the improvement

 Review of material uses and best management practices outlined in code requirements and our sustainability master plan



### 2020 Projects


 Project #1 at the intersection of Market Street and Central Way is completed.

- Project #2 is an RRFB at the intersection of 84th Avenue NE and NE 137th Street is completed.
- Project #3 is the RRFB at the intersection of Central and Main. Staff is currently waiting for a cost estimate from Puget Sound Energy to carry out their work in the area which consists of providing power to the RRFB system. Once the power is provided, the City's Contractor will complete the project by pouring the sidewalk at the southwest corner of the intersection.

### 2021 Projects

- Staff is in the process of selecting a consultant to design and produce the plans for the 2021 NSP projects.
- Project #1 is a crosswalk at Edith Moulton Park is scheduled to be constructed this summer.

- Project #2 and Project #3 are expected to be constructed in the 1st quarter of 2024.
  - RRFB on 132<sup>nd</sup> Ave NE at NE 129<sup>th</sup> St
  - RRFB and crosswalk across 124<sup>th</sup> Ave NE at NE 104<sup>th</sup> St
- The final cost of projects will be communicated once it is available.



### **Next Steps**

- CIP process for bidding, contracting, and construction
- Projects will be built in 2024
- Neighborhood Associations have expressed interest in reviewing NSP project criteria.
- Kirkland Alliance of Neighborhoods and Neighborhood Chairs will convene to discuss potential recommended changes.
