These stairs connect the Cross Kirkland Corridor to the Highlands and North Rose Hill neighborhoods. They get heavy use by school kids, stair runners, and pedestrians. Since the CKC interim trail was opened, stair use has increased significantly. The railroad tie steps were put in many years ago, and some of them are rotten. Many middle school kids take their bikes to school, or would like to if they could safely get their bikes up and down the stairs. Many 2018 NSP Application

people have been asking for a runnel. The stairs are long, steep, and uneven. A handrail would make the stairs much safer.



Each year the City of Kirkland's <u>Neighborhood Safety Program</u> funds a limited number of pedestrian and bicycle safety improvements throughout the city of Kirkland. Each neighborhood submits their top projects, and a panel of neighborhood representatives votes to prioritize the projects. The top priority projects receive funding. Letters of support from schools greatly increase chances for funding.

This year the Highlands neighborhood has chosen to submit an application for safety improvements to the Cotton Hill Park stairs:

- Replace rotten timbers
- Add handrail on one side
- Add bike runnel

These stairs connect the Highlands neighborhood to Kirkland Middle School via the Cross Kirkland Corridor. The stairs get heavy use by KMS kids. A bike runnel would provide a safe way for kids to get bikes up and down. The stairs are long, steep, and uneven, and a handrail would make them much safer.
