- New crosswalk on Lakeview Avenue, just north of 64th street intersection
- Connects existing railed public walkway/stairway going east up to 102nd Ave NE and NE 65th St intersection
- ADA Ramp, thermoplastic, removal of existing curb, replace of existing uneven grass/weed surface
- Evaluation of existing street light lumen strength
- Evaluation of re-position of existing north-bound Metro bus stop by several yards to align with ADA ramp to provide non-grass even surface to board Metro transportation

- <u>School Walk Route</u>: On existing school walk route; allows students residing in Sunset Shores Apartments and adjacent area to cross street safely
- <u>School Metro Bus Route</u>: Students board Metro #234 Bus for transport to Lake Washington School District non-bus served schools such as Choice Schools
- <u>Extends Neighborhood Pedestrian Connection</u>: Connects to existing public walkway/stairway which is underused due to lack of west direction option/currently deadends at Lakeview Avenue/pedestrians could continue to water front and access east bound Lakeview Avenue Metro routes.
- <u>Vulnerable Population</u>: Provides ADA ramp to address needs for 71 unit assisted living center currently not served (Lakeview of Kirkland at 6505 Lakeview)
- <u>Safety of Metro Bus Boarding Surface</u>: Provides stable surface to board Metro bus northbound (currently grass/weeds/curb) used by high school students and assisted living center residents
