RECOMMENDATION:

That the RCR Executive Board authorize RCR Executive Director Approval Authority by Resolution R-2023-14.

BACKGROUND DISCUSSION:

At the May 4, 2023 Executive Board meeting, exploring a resolution for setting the signature authority for RCR was discussed at the "Upcoming Agenda Items" portion of the meeting. The RCR Executive Director and RCR Administrative Assistant researched the signature authority for Program Managers, Directors, City Managers/Administrators, and Councils at the five RCR Agency principals, Northeast King County Regional Public Safety Communication Agency (NORCOM), and Puget Sound Emergency Radio Network (PSERN) as shown below.

The City of Kirkland acts as the Fiscal Agent for the RCR Agency per the Interlocal Agreement Section 15(b) and provides RCR Staff standard fiscal services, including billing, invoicing, account receivables/payables, revenue receipt, investment of funds, expenditure recording, and payroll per the Service Level Agreement (SLA) Section D(2) between the City of Kirkland and the RCR Agency.

The SLA also states in Section F. Policies:

"The Agency hereby approves the application of and adopts, for the purposes of this Agreement, the City's policies and procedures related to the services to be provided and the employees to be loaned by the City to the Agency hereunder. Such policies and procedures include, but are not limited to, policies and procedures relating to information technology, facilities, **Fiscal Agent, financial**, and personnel."

The City of Kirkland's fiscal authority thresholds fall within the norm when compared to the five principals, NORCOM and PSERN.

Board Action Requested:

It is recommended that the Board authorize RCR Executive Director Approval Authority of less than fifty thousand dollars as "Director" per City of Kirkland's fiscal policies by Resolution R-2023-14 attached.

Suggested motion language:

"Move to adopt Resolution R-2023-14 Authorizing RCR Executive Director Approval Authority of less than fifty thousand dollars as "Director" per City of Kirkland's Fiscal Policies."

A RESOLUTION OF THE REGIONAL CRISIS RESPONSE (RCR) AGENCY AUTHORIZING RCR EXECUTIVE DIRECTOR APPROVAL AUTHORITY.

WHEREAS, the Cities of Bothell, Kenmore, Kirkland, Lake Forest Park, and Shoreline have formed the Regional Crisis Response (RCR) Agency by interlocal agreement (ILA) to provide consolidated and expanded mobile crisis response services to the five-city region; and
