Describe the Project Scope:

The purpose of this project is to provide safety improvements to the intersection of 108th Ave NE & NE 137th Pl. As a result, there will be safer crossings of both streets at the entrance to Edith Moulton Park, enhancements for a safe route to school, and measures that will help reduce vehicular speeds along the 108th Ave NE corridor which is a cut-thru street for drivers, many who tend to exceed the speed limit by 10 mph or more.

The proposed improvements are depicted on the attached figure and listed below:

- New striped crosswalk (South leg, across 108th Ave NE)
- New striped crosswalk (West leg, across NE 137th Pl NE)
- SW corner improvements such as bulbing out the corner to reduce vehicular turning speeds and reduce pedestrian crossing distances. Treatments may include flex posts, new edge lines, and/or an upgraded curb ramp
- NW corner improvements to provide an ADA ramp and restored asphalt paving between the ramp and crosswalk
- The potential for an adjustment of an existing light or additional light is being evaluated by the City and PSE and will be included if required.

1. Neighborhood Benefit/Support (0–60 points)

Please explain how the project will address a recognized safety need (especially with school kids or other vulnerable populations) and result in a positive and lasting neighborhood benefit (e.g., creates an important neighborhood pedestrian or bicycle connection):

The need for this project has long been identified within the neighborhood. 108th Avenue NE is a street within Juanita that collects a lot of traffic flow from nearby residents and also those from outside Kirkland who use the street as a cut-thru route. Edith Moulton Park (at NE 137th Pl) and Helen Keller Elementary (at NE 140th St) are both located on this street. Further, 108th Avenue NE is a school walk route for both Helen Keller Elementary and nearby Juanita High School. This street is also identified in the Kirkland Transportation Master Plan to be a recommended greenway. Within the Kirkland Neighborhood Greenways Guide for Implementation, this is listed as the 'Juanita HS' and of the 14 projects this corridor tied with others for the 2nd highest score in categories of 'Connects Destinations' and 'Improves Safety'.

Beyond the current needs already identified through these sources, members of our neighborhood understand that [WSDOT's project \(https://www.wsdot.wa.gov/Projects/I405/NE132ndStInterchange/Default.htm\)](https://www.wsdot.wa.gov/Projects/I405/NE132ndStInterchange/Default.htm) to construct a new interchange at I-405 and NE 132nd St will increase traffic along this corridor with construction on that project starting in 2021 and completion in 2023. As this NSP cycle will complete improvements by May 2021, we believe this is an appropriate time to provide needed improvements to address immediate safety concerns as well as helping to address future concerns.

During the November General Meeting for the Juanita Neighborhood Association, a short-list of 3 projects were presented for input. Following discussion with 25 people in attendance at the meeting, there was unanimous support from all neighborhood members for this project.

In addition to sharing this project at the November meeting, by email, and on the JNA website, the principal of Helen Keller Elementary as well as the PTA were contacted following the Project Conference meeting which refined the scope of project improvements.

As noted above, this project has widespread support within the immediate portion of the neighborhood. For benefit of the community beyond the neighborhood, this project stands to benefit all users of Edith Moulton Park. As Edith Moulton is the largest park in North Juanita (and was recently improved), it has become a destination for residents throughout Kirkland and beyond the City. The ability to enhance the entrance to the park and provide a safer access for these users will be a wonderful benefit to the greater community.

During the most recent Welcome to Juanita event, our yearly picnic which took place in Fall 2019, the possibility of intersection improvements were discussed with several attendees from the immediate neighborhood area, miles

away within Juanita, and beyond. Each person fully supported improvements and several even questioned why at least one crosswalk wasn't installed as part of the recent park improvement project!
