## **DEVELOPMENT SERVICES FEE CHANGES**

## **Effective January 1, 2026**

- All Development Services fees, Public Works Fees, and Fire Department Annual Permit fees will increase by 2.7% per the Consumer Price Index for Western Washington (CPI-W).
- Park, Fire, and Transportation Impact Fees will increase by 2.7% CPI-W.
- <u>Please note for future planning:</u> Park, Fire, and Transportation Impact fees for Cottages and Accessory Dwelling Units (ADUs) will be adjusted by Ordinances 4901 and 4904 and/or by CPI-W every 6 months through 2027. Impact fees for those development styles are being phased in over a three-year horizon, beginning in July 2025. Complete ADU building permit applications received on or after July 1, 2026 will be charged impact fees. ADUs 800 square feet or less in size will continue to be exempt from these Impact fees.
- School Impact Fees will increase pursuant to Ordinance O-4910.
- The Cascade Water Alliance Regional Capital Facilities Charge (RCFC) will increase per Board Resolution No. 2024-13.
- Water, Sewer, and Stormwater Capital Facility Charges will increase by 2.7% CPI-W and rounded to the nearest dollar.

Complete permit applications that are submitted prior to January 1, 2026 will be vested to all 2025 fees, with the exception of the RCFC as explained on the following page.

## **Cascade Water Alliance Regional Capital Facilities Charge**

Cascade Water Alliance's Regional Capital Facilities Charge (RCFC) will increase per Board Resolution No. 2024-13. <u>There is no vesting of this rate. The rate due will be the rate in place at the time of payment.</u>
