Specific work includes, but is not limited to the construction of a new signalized intersection, including roadway illumination improvements, new curb ramps at the intersection, 2" grind and overlay of the intersection bounded by the curb returns, and new left-turn lanes. The estimated cost for this project is in the range of \$1,250,000 to \$1,550,000 based on the base bid.
