Comcast, as part of its negotiated franchise agreement with the City of Kirkland, provides a reduced cable television billing rate for low income senior residents or low income residents with a permanent disability. The reduced rate is a 30% discount off of Basic or the Basic portion of Expanded Basic when not discounted by inclusion in a promotion or programming package.

To qualify, you must complete the attached City Affidavit for Reduced Cable Rate and prove:

- 1) You or your spouse are either 65 years of age or older <u>or</u> have a permanent disability as determined by the Social Security Administration.
- 2) If single, you receive \$2,637.50 or less gross monthly income. If married, you receive \$3,012.50 or less gross monthly income.
- 3) You are a legal owner or tenant of your dwelling unit.

You will need to attach the following documents verifying income:

- 1) The first page of your latest IRS Form 1040/1040A/1040EZ tax return. If you do not file one of these, please fill out the attached Alternate Income Verification Form.
- 2) Attach Form SSA-4926SM or SSA-1099 that is sent to you at the beginning of each year from Social Security Administration to tell your benefits for the year.

We will process your application when we receive the completed forms back from you. You may be requested to provide additional verification of your status as a low income senior resident or resident with a permanent disability. Completed forms should be delivered:
