Lynn Zwaagstra shared that City Council is focusing on the operation policies of City Boards and Commissions. The hope is to have more consistency between board functions and equitable processes and increasing diversity of membership.

Leslie Miller shared that there has been a significant amount of focus on hiring two new staff to join the Human Services Division. The contracts for the 2021-22 grants are just about completed, just in time for the first quarter reports that are due April 15th.

Subject: EBC-Eastside Baby Corner Presentation

RECOMMENDATION

Staff recommends that the Human Services Commission receive an update from EBC (Eastside Baby Corner).

BACKGROUND DISCUSSION

EBC-Eastside Baby Corner's mission is to help kids reach their full potential by meeting basic needs today. The agency does this by distributing orders of children's essential items through a 50+ agency partner network. In 2019 it delivered 111,009 orders of diapers, formula, car seats, pack n' plays, clothing, shoes, newborn supplies, school supplies and hundreds of other items valued at \$3.6 million dollars. EBC is centered in Issaquah, WA. The Northshore hub began operating in 2015, moving into its present Kenmore location in 2017. EBC – West Sound was launched by a team of volunteers, opening in 2016 in Bremerton.

The City of Kirkland fully funded its 2021-22 ask of \$11,318 each year.

RECOMMENDATION

Staff recommends that the Human Services Commission receive a presentation from Child Care Resources.

BACKGROUND DISCUSSION

Child Care Resources works with families, child care providers, community organizations and advocacy groups in order to improve the quality of early childhood care in our region. The agency supports families in their search for child care, assist families experiencing homelessness with child care costs, coach and provide resources for child care professionals, and train and empower low-income and refugee women pursuing careers in early learning.

Child Care Resources requests funding from the City of Kirkland for its Information and Referral/Technical Assistance program. This program assists families in their childcare search by referring them to childcare providers, community resources, and education about quality childcare. CCR also provides customized, culturally relevant and inclusive Technical Assistance and Training to childcare providers to strengthen their delivery of childcare.

It is receiving \$7,500 in 2021 and 2022 from the City of Kirkland.

RECOMMENDATION

Staff recommends that the Human Services Commission receive a presentation from Child Care Resources.

BACKGROUND DISCUSSION

Indian-American Community Services (IACS) formerly known as India Association of Western Washington (IAWW), is the longest-serving Indian community based organization in the Pacific Northwest. Secular and volunteer-driven, the IACS works to connect and empower the Asian-Indian community through programs, services, and advocacy for people of all ages and all life stages. As a result, the IACS is able to involve its full community in ways that incorporate and respect cultural traditions and values.

The City of Kirkland are funding the two following programs \$5,000 each.

The Cultural Navigation Program offers community members access to staff, workshops, training and information to connect them to basic resources, address their concerns with support services continuing to follow up and ensure that needs are met comprehensively. IACS is a safe and familiar space for our community to reach out during challenging times to access emergency and crises care services from food, housing, legal, healthcare regardless of religion, gender, language, or socio-economic status.

The Mental Health Support Program provides culturally nuanced services for mental health support of Asian Indian families, seniors and youth addressing body, mind and soul. This program uses a community input driven approach to identify, address mental health struggles comprehensively by hosting weekly conversation driven moderated support groups, wellness programs (created with input from youth and seniors), yoga, meditation, art, music, monthly webinars, as needed personalized counseling and connection to resource groups.
