Subject: IDENTIFYING NEXT FUNDING PRIORITIES

#### **RECOMMENDATION:**

That the Human Services Commission continue their discussion of identifying the next funding priorities for funding available for human services grants in 2022.

#### BACKGROUND DISCUSSION:

In addition to the regular human services grant funding allocated in the City's 2021-2022 budget, COVID Community Development Block Grant, Human Services Reserve and ARPA funding have been apportioned in 2021. Additional Community Development Block Grant funding is available to allocate for 2022. At the November 23<sup>rd</sup> meeting Commissioners heard a staff presentation the results of a nonprofit agency survey completed earlier in the year. Following the presentation, Commissioners had the opportunity to meet in two breakout groups to discuss the information shared and identify the highest priority needs to fund for 2022. At the December 21<sup>st</sup> meeting, Commissioners will have an opportunity to discuss the priorities raised in the two breakout sessions.

- **Subject:** THE DRAFT DIVERSITY, EQUITY, INCLUSION, AND BELONGING FIVE YEAR ROADMAP

#### **RECOMMENDATION:**

That the Human Services Commission review and provide feedback on the City's draft Diversity, Equity, Inclusion, And Belonging Five Year Roadmap.

#### **BACKGROUND DISCUSSION:**

Following the tragic killing of George Floyd by a police officer on May 25, 2020 in Minneapolis, Minnesota, numerous marches and rallies were held in Kirkland calling for an end to structural racism and for the City to demonstrate that Black lives matter. At the June 16, 2020 Council meeting, the Council issued a statement directing the City Manager to develop a framework for the City's response to the community. On August 4, 2020, the City Council adopted Resolution R-5434 (R-5434). The Council committed the City to create a community where Black people feel safe and respected and interpersonal, institutional and structural racism no longer exists.

Section 3b of R-5434 called for "Contracting for a comprehensive City organizational equity assessment to identify gaps in diversity, equity and inclusion in all areas of City policy, practice and procedures, and to identify proposed actions steps to address these gaps." The City contracted with Chanin Kelly-Rae Consulting LLC to conduct this assessment. As part of that work, Ms. Kelly-Rae worked closely with City staff on the draft Diversity, Equity, Inclusion, and Belonging (DEIB) Five Year Roadmap found here, which will be one chapter of the City's Equity Plan of Record. The DEIB Five Year Roadmap is structured to align with the King County Equity and Social Justice Strategic Plan and contains the same six goal areas as the King County plan. Within those six goal areas are currently a total of 18 goals and 67 objectives. The King County strategic plan is available here.

The City is asking City and community stakeholders to review and comment on the draft document. While the document will be a dynamic and living document, meant to evolve as our collective community evolves, the City Council is expected to adopt the City's first formal version of it in early 2022. This document serves to address inequities in both the government and the larger community. The document lays out what results the City will address, not how.

As you review the draft document in preparation for the Commission meeting on Tuesday, December 21st, please consider the following:
