2025-2026 GRANT APPLICATION REVIEW UPDATE Subject:

RECOMMENDATION

That the Human Services Commission review the staff recommendation for the application review schedule and number of applications to be reviewed by the Commission.

BACKGROUND DISCUSSION

The City of Kirkland received 128 applications for the 2025-26 human services grant cycle. The total number of applications was a 17% increase from the previous cycle in 2023-24.

Application Review Timeline

Attachment A outlines the application review schedule and the list of applications that will be reviewed at each Commission meeting. The Commission is responsible for reviewing applications ahead of each meeting and completing the review tool in Share One, allowing them to be prepared to discuss the scheduled applications at the meeting.

Staff Review

Following direction from the Commission, staff conducted a preliminary review of all applications received to identify any applications that may not require Commission review and discussion. Staff used the following criteria to review the 128 applications submitted.

- <u>Human services organization and/or services:</u> if a program does not provide human services or does not have a 501(c)(3) and/or fiscal sponsor, the application was removed from the review pool.
- <u>Incomplete application:</u> if information was missing that was required, the application was removed from the review pool.
- <u>History of funding:</u> if a program did not receive funding in the past and there were not substantive changes nor did it align with Commission priorities, the application was removed from the review pool.
- <u>Kirkland residents served:</u> if the program offers services in a location that is difficult for Kirkland residents to access or serves a small number of Kirkland residents, the application was removed from the review pool.

Based on the criteria above, staff are recommending 20 applications be removed from the Commission review schedule and subsequently grant funding consideration. **Attachment B** provides the list of applications and staff justification. The Commission will have a chance to discuss and provide feedback at the May 14th meeting.

RECOMMENDATION

That the Human Services Commission review application submissions that meet Goal Area 3 and 5 objectives in preparation for the May 14, 2024 meeting.

BACKGROUND DISCUSSION

The City of Kirkland has five community goal areas that all community members should be able to achieve. First developed by the United Way of King County, and later adopted by several local jurisdictions including Bellevue, Redmond, Seattle, King County, and Kirkland, these Community Goal Areas reflect the belief that all people should have:

- 1. Food to Eat and a Roof Overhead
- Supportive Relationships within Families, Neighborhoods and Communities
- 3. Safe Haven from All Forms of Violence and Abuse
- 4. Health Care to be Physically and Mentally Fit as Possible, and
- 5. Education and Job Skills to Lead an Independent Life

At the May 14, 2024, meeting, Commissioners will begin discussion of applications in Goal Area 3: Safe Haven from All Forms of Violence and Abuse and Goal Area 5: Education and Job Skills to Lead an Independent Life. 
