**Subject:** 2025-2026 OPIOID FUNDING RECOMMENDATIONS

# **RECOMMENDATION**

That the Human Services Commission receive the staff recommendation on allocating the City's opioid settlement funds in 2025-2026.

# **BACKGROUND DISCUSSION**

The City of Kirkland, along with local governments and the State, filed federal lawsuits against certain opioid manufacturers and distributors in Spring 2020. Following completion of the trial, several opioid distributors have entered a multimillion-dollar settlement that will be split equally (50/50) between the State and the local jurisdictions. In May 2022, the City Council approved a resolution authorizing the City Manager to sign a Memorandum of Understanding with other local jurisdictions in Washington regarding the allocation of litigation and settlement fund stemming from the City's lawsuit against certain opioid manufacturers and distributors.

Over the next 17 years, the City is anticipated to receive .5453525246% of the total Opioid Funds distributed to local governments in Washington, equivalent to approximately \$2.31 million. However, additional settlements are still underway, and the final amount the City will receive is still to be determined.

The City is required to use Opioid Funds for approved purposes outlined in the MOU, which broadly outline hundreds of examples in how funds can be used to address a broad aspect of Opioid Use Disorder and/or any co-occurring Substance Use/Mental Health Disorder. Examples include support people seeking treatment and recovery, providing access to housing, support screenings to identify persons in need of assistance, purchase Naloxone for first responders, and support outreach and prevention programs.

In the 2023-2023 budget, the City Manager proposed \$80,000 of Opioid Funds be disbursed through Kirkland's Human Services Division to offset the cost of the Homeless Outreach Coordinator position. For 2025-2026, the City Manager is proposing \$658,498 in opioid settlement dollars as one of the sources to fully fund Option B of the human services grant recommendations approved by the Human Services Commission.

### **NEXT STEPS**

Staff are recommending \$658,498 (\$329,249 per year) of opioid funding to support funding Option B in the City Manager's proposed budget for 2025-2026. At the meeting, Commissioners will discuss the staff recommendation and provide feedback.

# **RECOMMENDATION**

# **BACKGROUND DISCUSSION**

Every year, the Human Services Commission considers and approves their workplan for the subsequent year.
