Subject: PROS Plan Update

RECOMMENDATION

That Park Board receive an update on the Parks, Recreation and Open Space (PROS) Plan process and upcoming milestones.

BACKGROUND DISCUSSION

Each month staff will provide the Park Board with a monthly progress report. In September, a postcard was sent to 5,000 randomly selected Kirkland homes to support the statistically valid survey component. The paper survey then arrived at these same homes. The survey may be completed either as a mail-in survey or community members can take the survey online with a unique login and password. To date, we have received 313 completed online responses and 125 paper surveys, for a total of 438 surveys.

Additionally, the consultant met with the Park Board for a focus group on September 8th, and staff met with the Youth Council on September 13th to gather their feedback and relay the youth survey information to the consultant. Staff conducted a community conversation about Off-Leash Dog Areas and the Pop-up Dog Park program on September 29th. The meeting was recorded and can be viewed on our webpage. We had 118 registrants with 74 attendees for the conversation. Information from all these meetings will be used by the consultant to assist in making recommendations for the PROS Plan.

Lastly, we have made progress on the following:

- Athletic Field Use and Demand Analysis Study Preliminary findings from the Athletic Field Demand study were presented to City Council on October 5th.
- Park Inventory Assessment Reports Staff have received and approved the park inventory reports that include data the consultant collected from park visits that include an inventory of each park's design and ambiance, comfort and convenience amenities, and the number and quality of park components.
- Americans with Disabilities Act (ADA) Evaluation and Transition Plan Staff have begun
 their review of the ADA reports on all relevant facilities, programs, and services to
 identify existing and future accessibility needs.

• Internal Stakeholders Meetings – The consultant will interview both Parks Maintenance and Operations staff and the Recreation and Programming staff on October 20th.

The following schedule outlines major milestones to reach the end goal of adoption of the PROS Plan by City Council.

Subject: Park Board Liaison Assignments

RECOMMENDATION

That the Park Board discuss neighborhood liaison assignments and make representative appointments. Additionally, it is recommended that the Park Board update the community about various ongoing programs and projects associated with the Parks and Community Services Department.

BACKGROUND DISCUSSION

The Park Board mission statement is as follows:

"The mission of the Park Board shall be to provide policy advice and assistance to the Department of Parks and Community Services (PCS) and City Council in order to ensure the effective provision of Parks and Community Services programs and facilities to the residents of the City of Kirkland."

The job description of the Park Board discusses involving the community and meeting with volunteer groups and neighborhoods to determine needs and interests. Some years ago, the Park Board decided to assign each board member to be the liaison with one or more neighborhood organizations. These assignments are typically made just after new Park Board members are appointed by City Council.

Park Board members have requested assistance in meeting liaison role expectations. After discussion, it was determined that the following two strategies would be used to prepare Park Board members for neighborhood meetings.

- Park Board members should use the monthly report provided by staff and pick out key items to convey to the neighborhoods. This could be followed by questions and feedback.
- Staff will highlight a topic or a discussion question for use with neighborhoods that would solicit community input for consideration. Discussion questions could be related to upcoming Park Board agenda items or be generic.

LIAISON ASSIGNMENTS

Current Neighborhood Liaison Assignments are listed below. This was last updated at the June 9, 2021 Park Board meeting following the appointment of the newest Park Board members. Not all members of Park Board were present at this meeting, so it was requested that this list be updated. The Board may assign representation in any manner desired. This may include opening all assignments and selecting new representation or only assigning unassigned neighborhoods. Many neighborhood associations are holding meetings virtually. Subject: Joint Meeting with Council

RECOMMENDATION

That the Board begin considering topics for the joint Park Board and City Council meeting scheduled for February 15, 2022.

BACKGROUND DISCUSSION

Each year, the Park Board typically has a joint meeting with City Council. Originally, Park Board was scheduled to meet with City Council on October 19, 2021. At the August 11, 2021 Park Board meeting it was requested to delay this meeting until the PROS Plan was further along and to provide the new members of the Board to become more familiar with the issues and concerns of the community prior to meeting with City Council. Staff have rescheduled this joint meeting to February 15, 2022.

Past topics for these joint meetings have focused on top City Council priorities and priorities for Park Board, including park acquisition, growth and development strategies and other specific areas of interest to the Board, such as the desire for an indoor aquatic/recreation center in Kirkland and off leash dog opportunities.

Staff will check in with Park Board on this topic at all meetings moving forward in order to develop a draft list of discussion items. Additionally, staff will continue to provide updates on the progress of the PROS plan and other relevant issues. In January, Park Board will review and finalize the list of discussion items. Staff will use this list to write a memo for City Council that outlines the identified discussion items and will provide additional background information as appropriate. At the February 9, 2022 Park Board meeting, staff will prep the Park Board for the joint meeting with City Council by reviewing the final list of discussion topics, discuss any feedback received from City Council, and discuss the flow and logistics of the meeting.

Subject: Advocating for the Forbes Creek Stairs.

Dear Colleagues,

I write to you today as a long-term resident of the City of Kirkland.

I believe the city has simply not paid attention to the Forbes Creek Steps. At best, I think the city has treated it as a peripheral adjunct doing the absolute bare minimum possible.

Today, the state of neglect of this community asset is so bad that it poses a **risk** to the health and well being of the citizens and **a serious liability** to the city. It is entirely possible that the poor condition of the steps will lead to someone slipping and breaking a leg (or worse).

Even more importantly, the City of Kirkland should recognize this as a **beloved community asset** that is cherished by so many. Those that climb these steps are diverse and come to this as part of their **health process**.

At a minimum, I believe the city should take these steps:

- 1- Install signs at the base and the top of the park to help citizens navigate the steps. Include signs such as "Slippery, When Wet" and "Requires Cardio Fitness". Currently, there is a nondescript "No Dumping" sign!
- 2- Install an anti-slip strip on every step. This should be a relatively easy fix.
- 3- Remove rotted boards and replace them with fresh ones.
- 4- Install a board at the Forbes Creek Dr. entrance naming the stairs and providing a narrative extolling its importance to the community.
- 5- Fix the current parking lot with proper paving.
- 6- Install a second railing to support those who are stepping down- not just those that are climbing.
- 7- Consider adding a bench at the bottom and top to help those that need 2 minutes of rest before climbing again.

I send this message with the confidence that we can get together and do much better.

I hope to see engagement from all of you. I suspect that the current condition is due to some arcane juridisctional divide with the utility company. If so, let us engage and get those that can make a decision in one room.

I hope to see you climbing soon!
