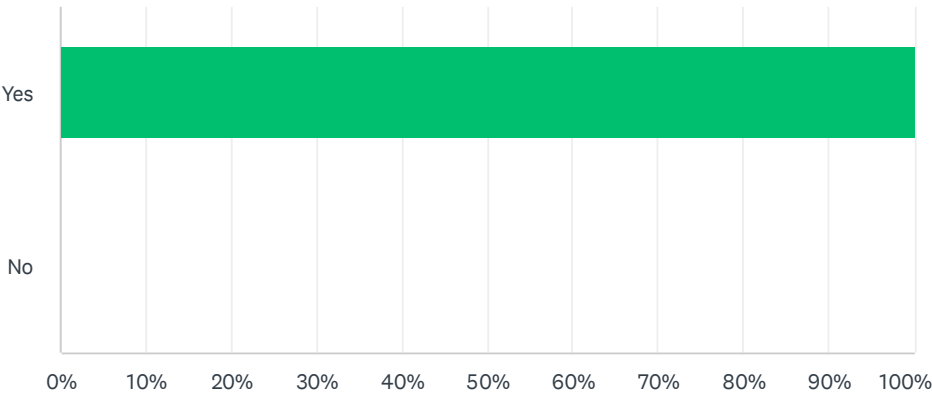

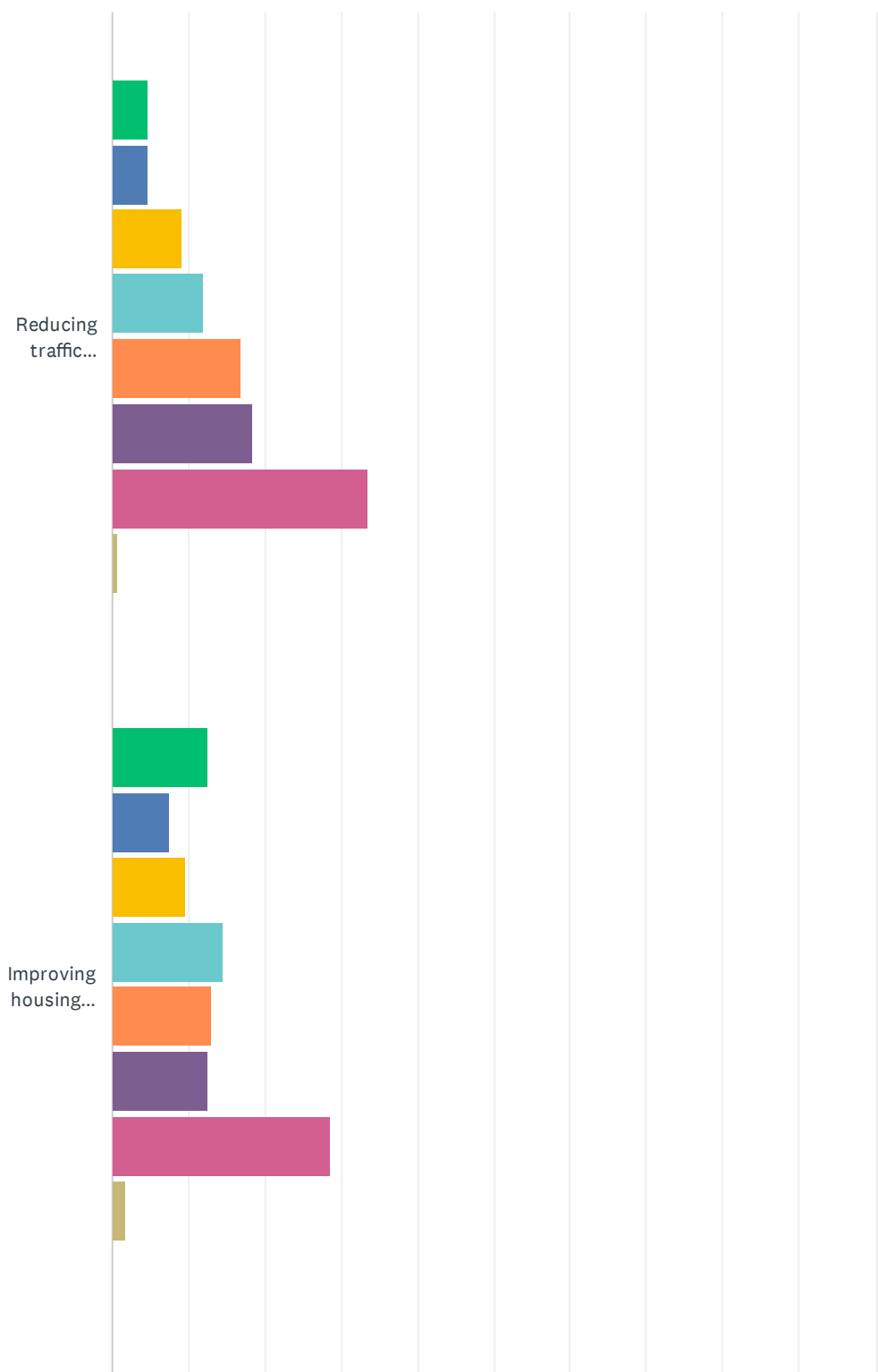

Q2 What do you think is the most important issue facing Kirkland today?

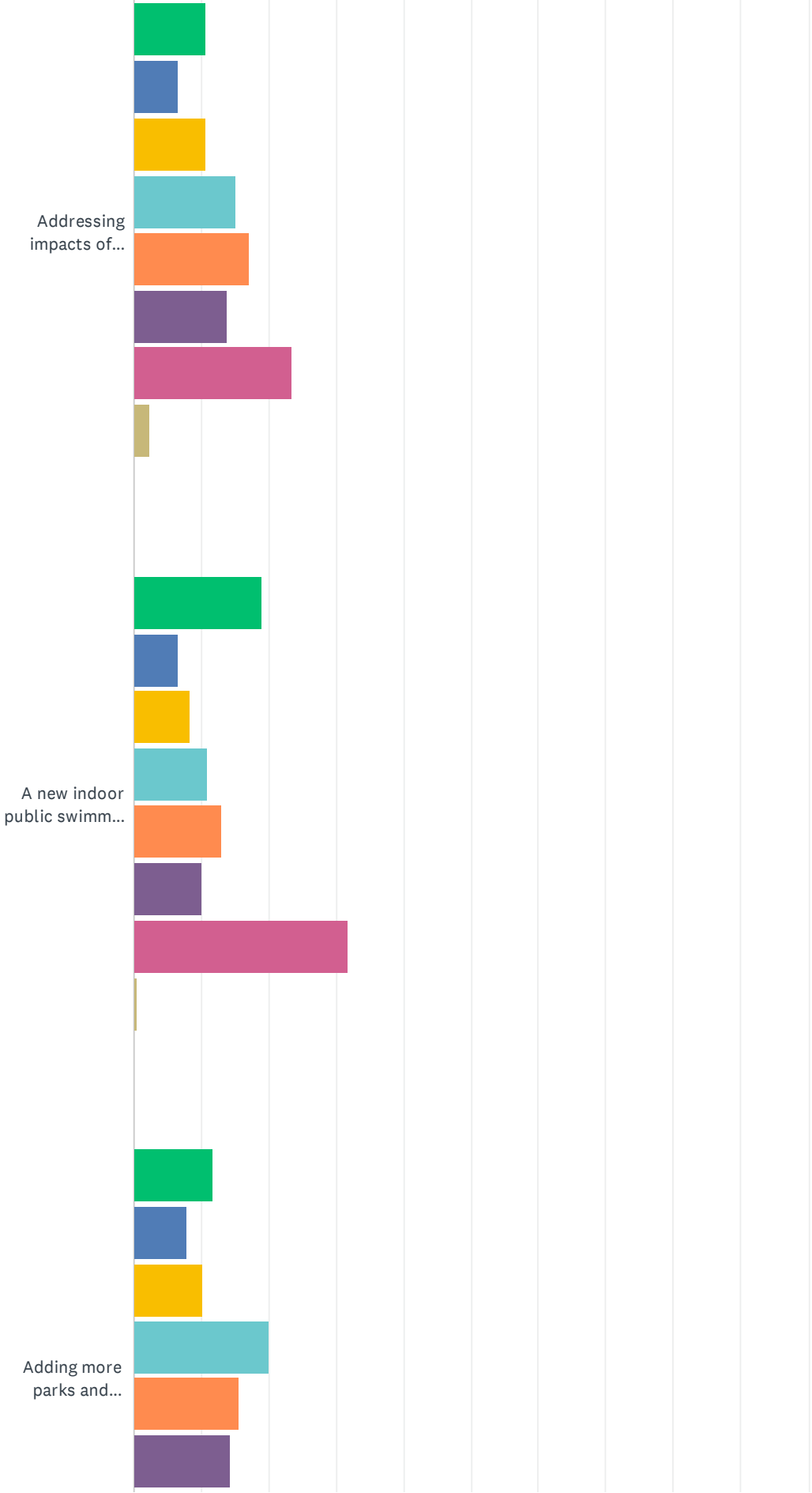

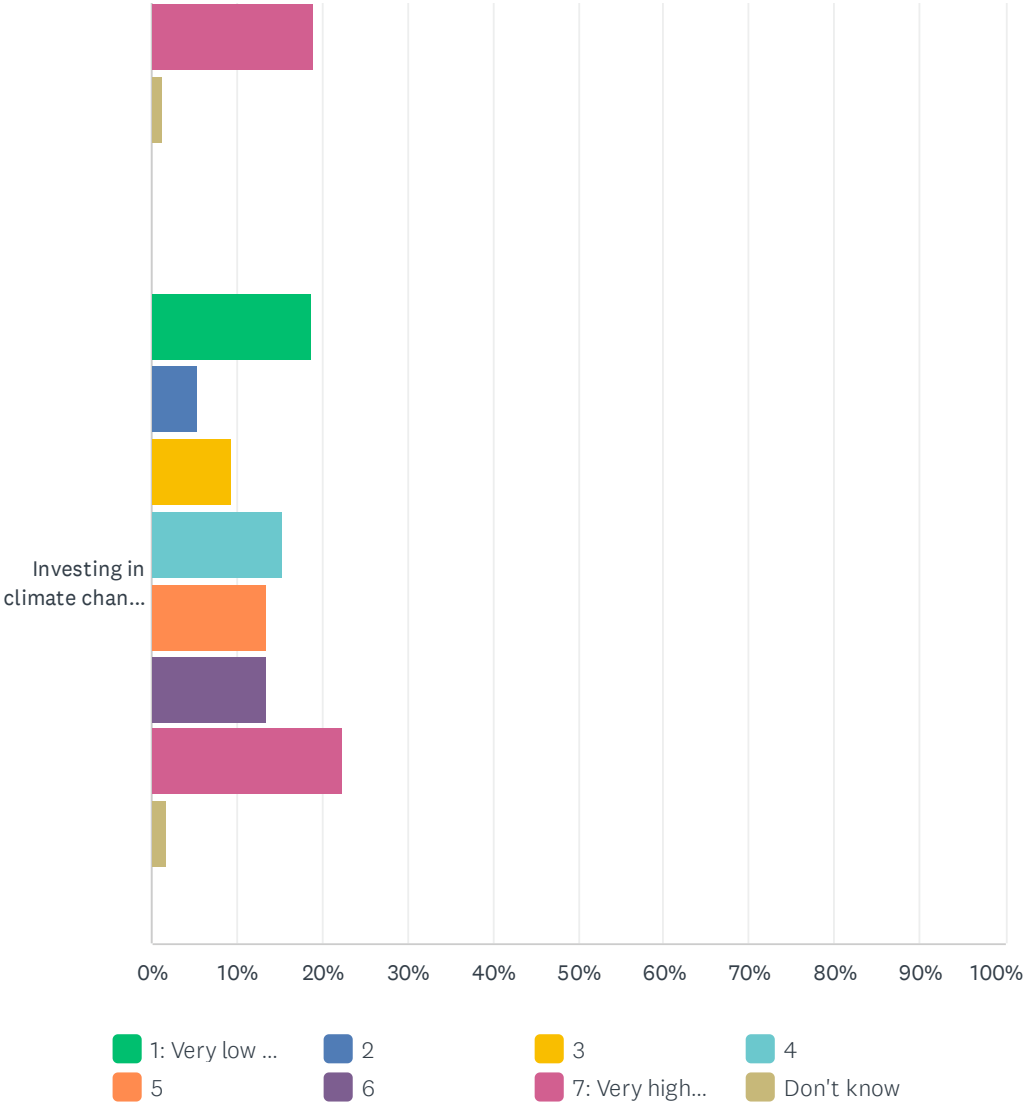

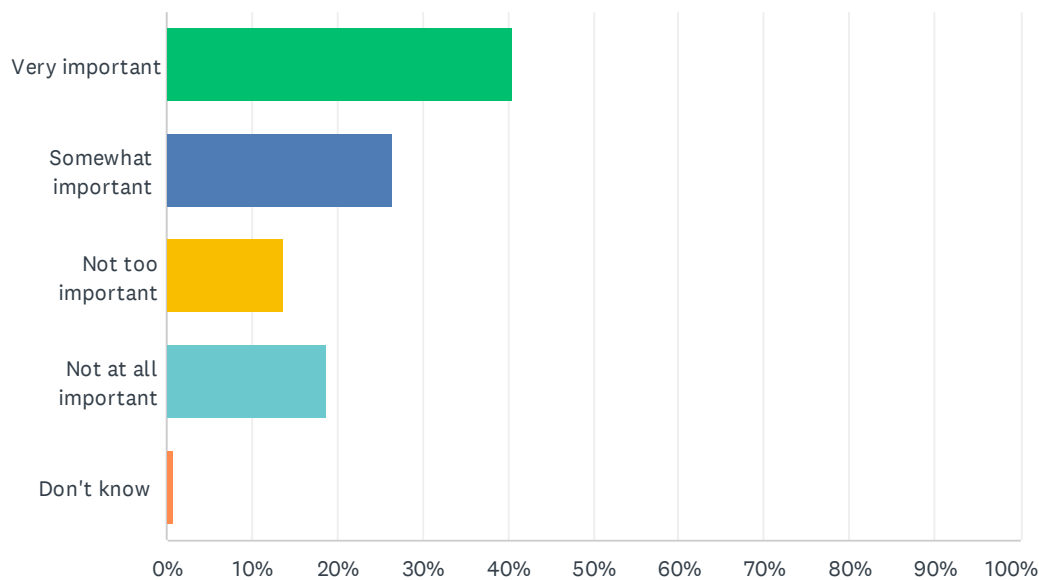

Q4 The City of Kirkland is considering a proposal to fund a new aquatics, recreation and community center, and improvements to the parks and recreation system. The proposal would fund new public facilities and programs including recreation and lap pools, a multi-court gym, wellness and fitness classes, a community gathering space, expanded youth programs, extended hours at lifeguarded beaches, more year-round park restrooms, new sport courts, and the purchase of green space in northwest Kirkland to develop Green Loop trail segments. This proposal would increase the City’s regular levy permanently by approximately 23.5 cents per \$1,000 assessed value for collection beginning in 2024. 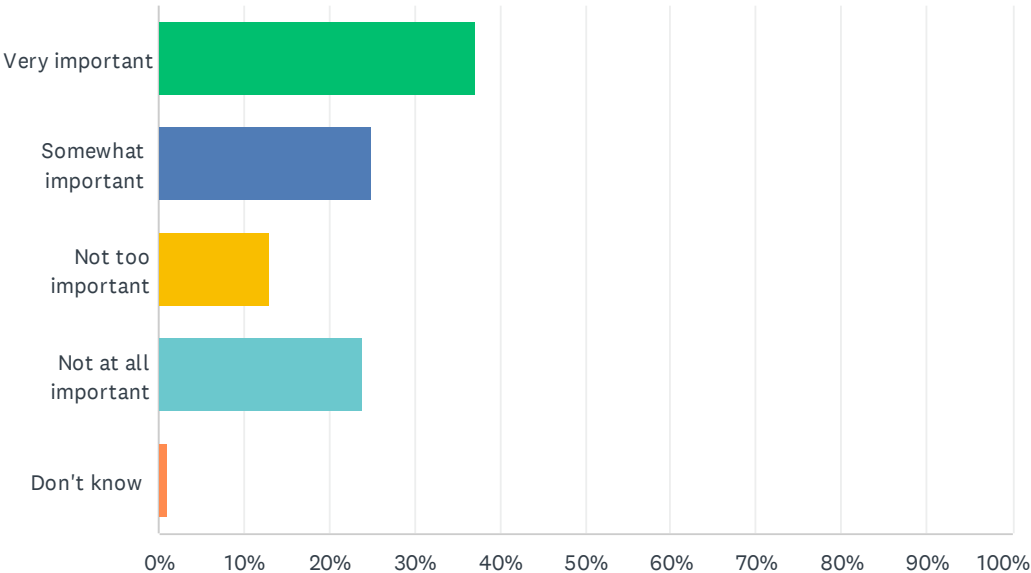

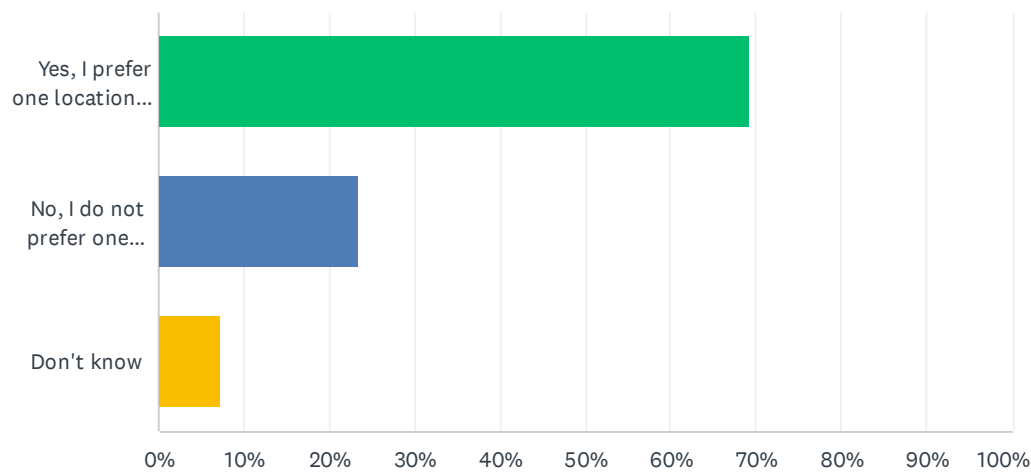

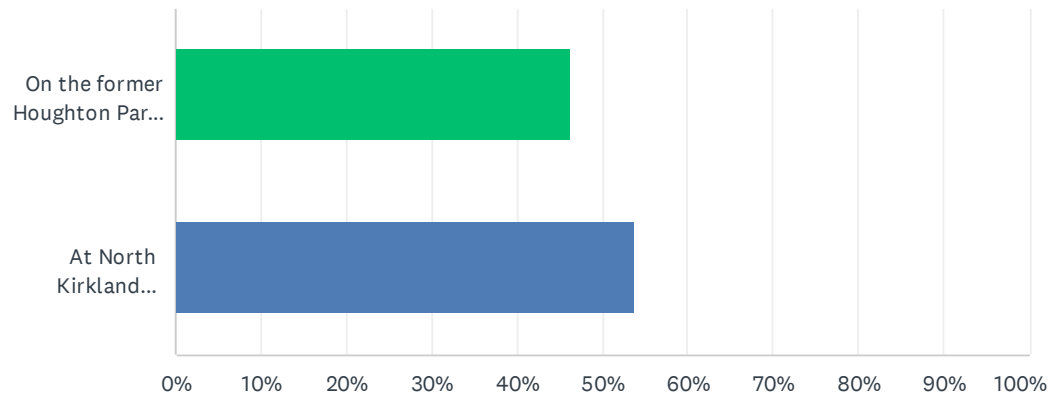

Q11 Which location do you prefer?

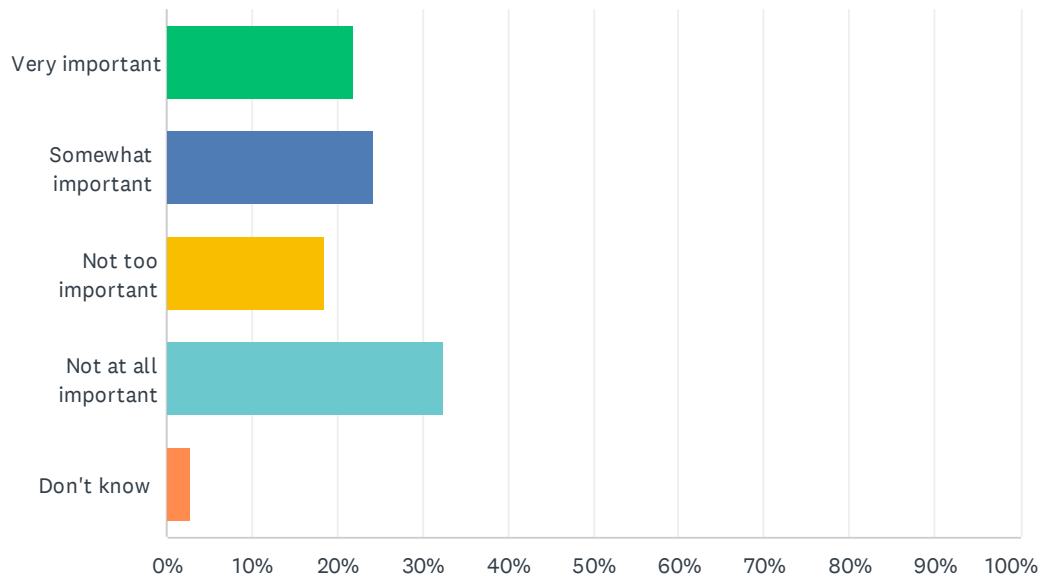

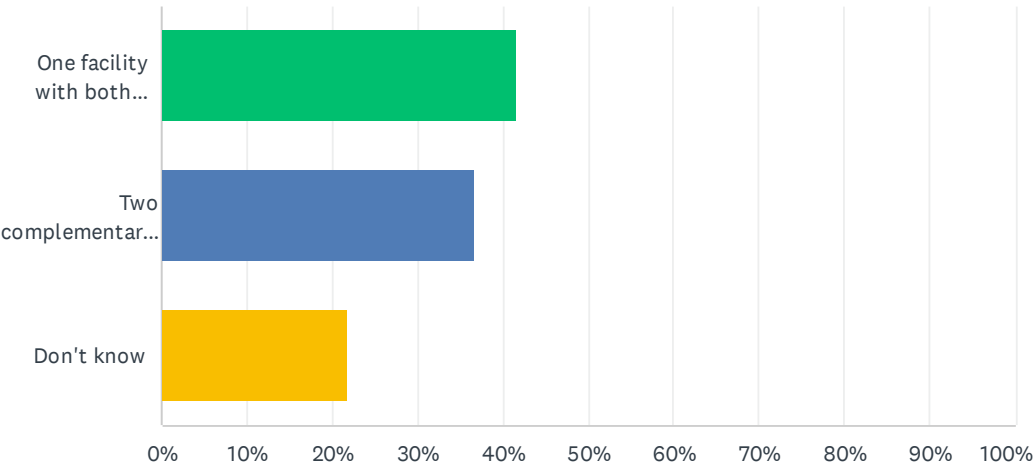

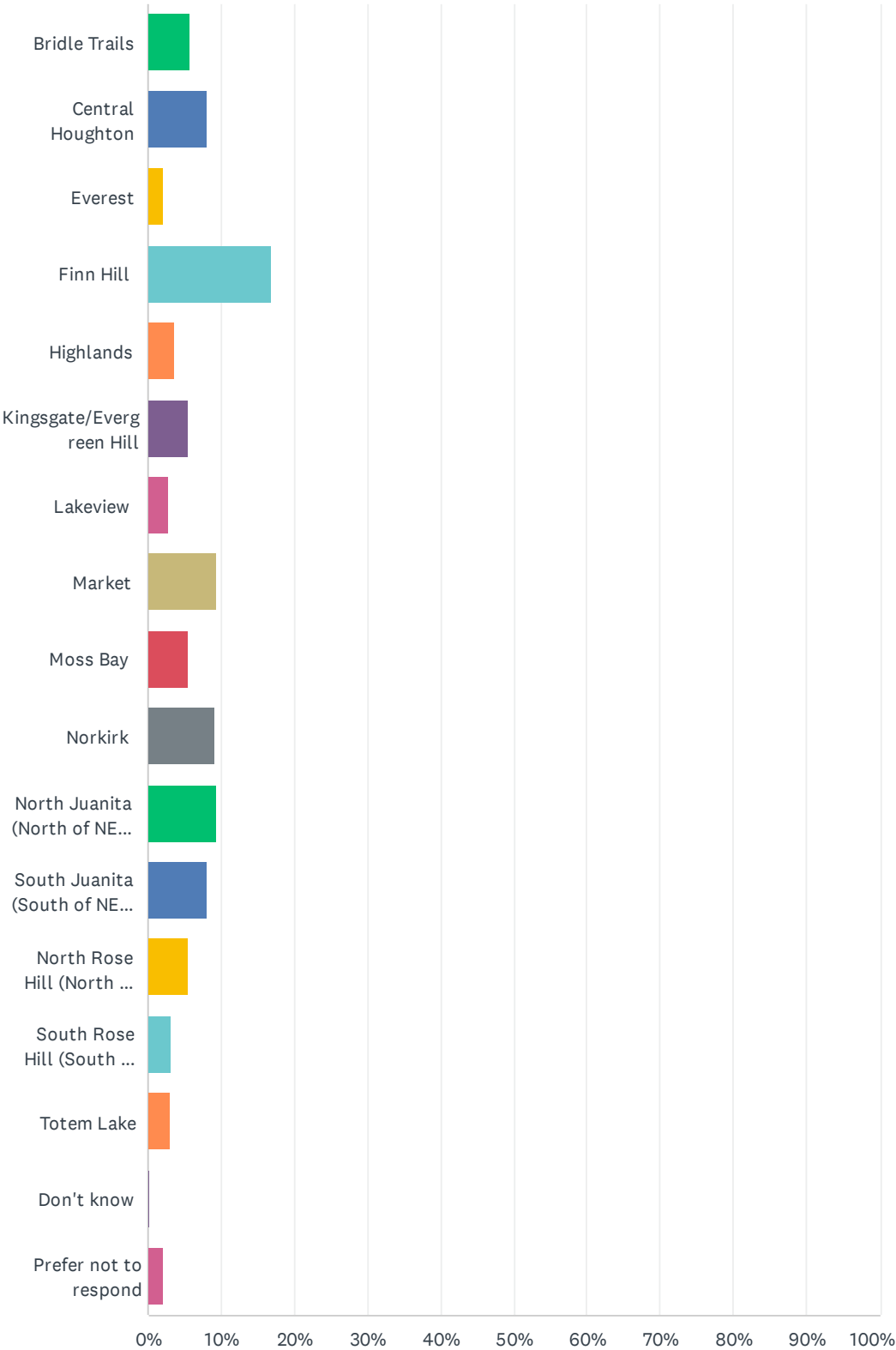

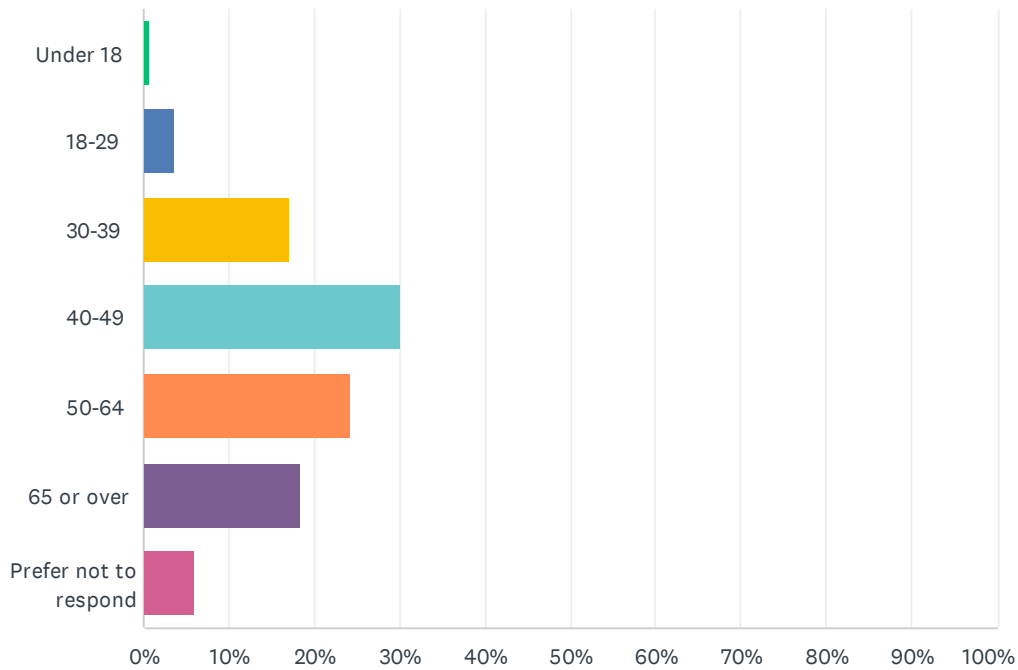

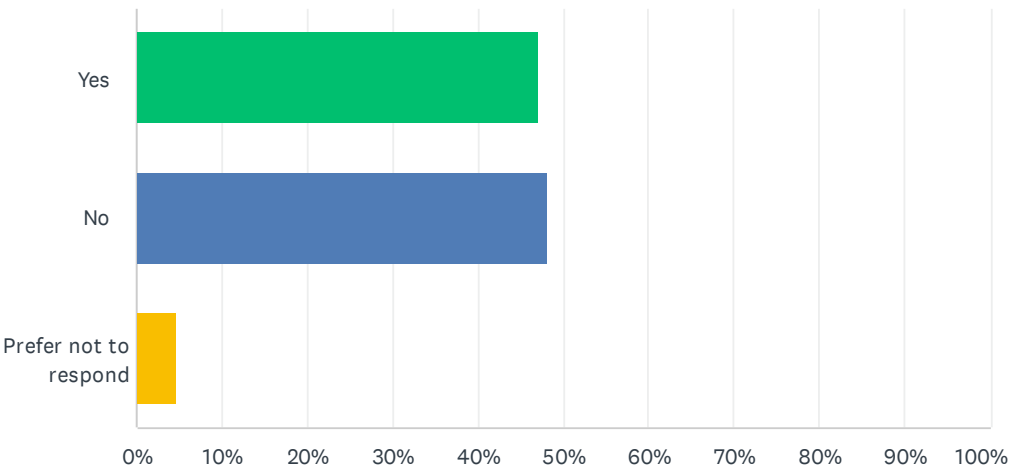

Q16 Do you have any children under 18 living in your household?

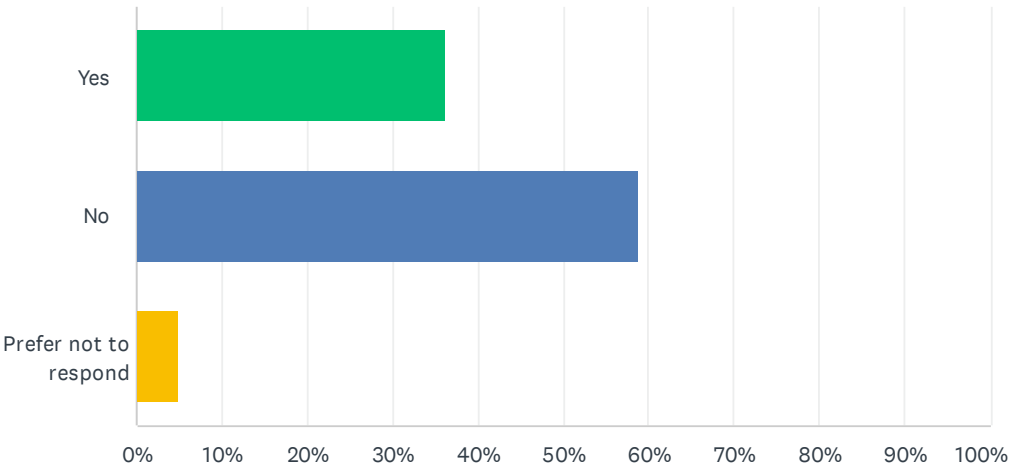

Q17 Do you have any children under the age 12?

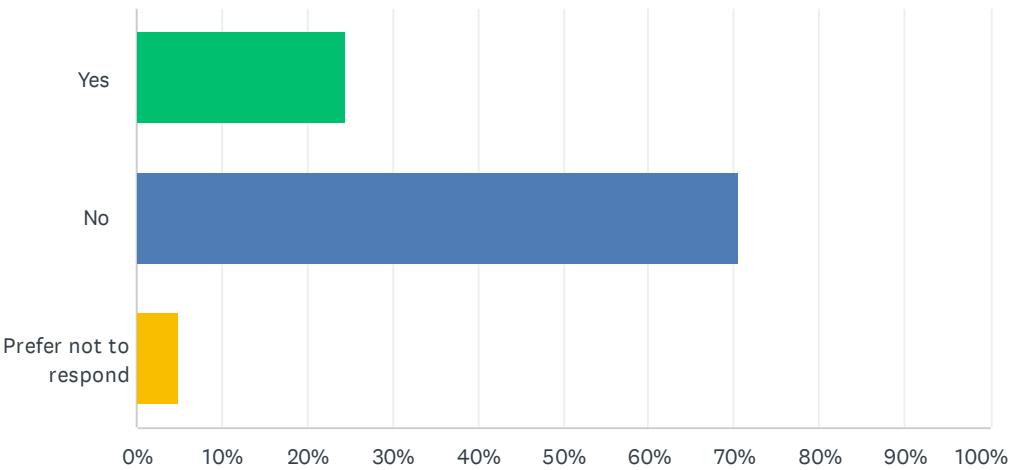

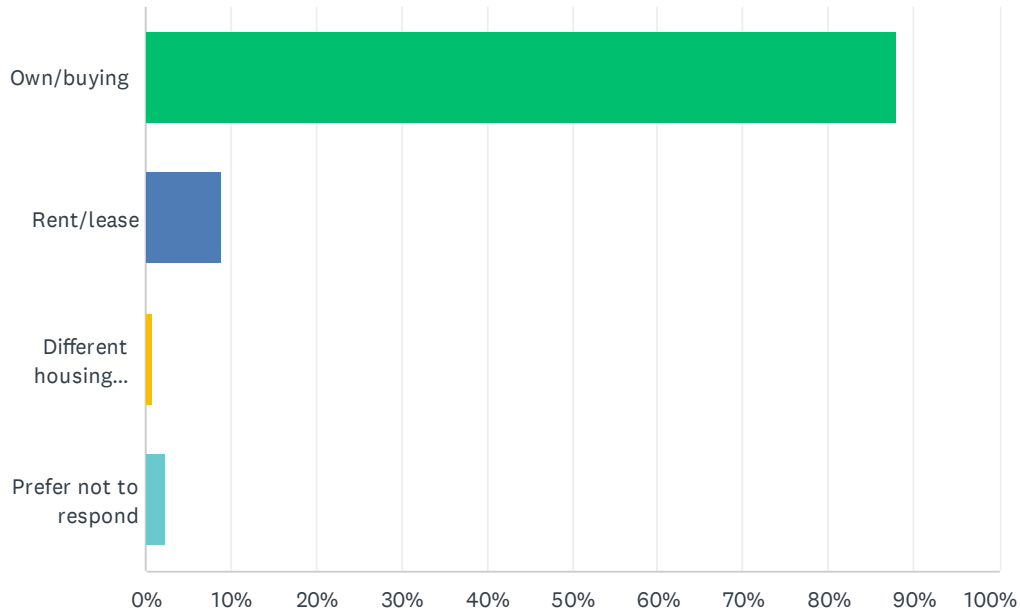

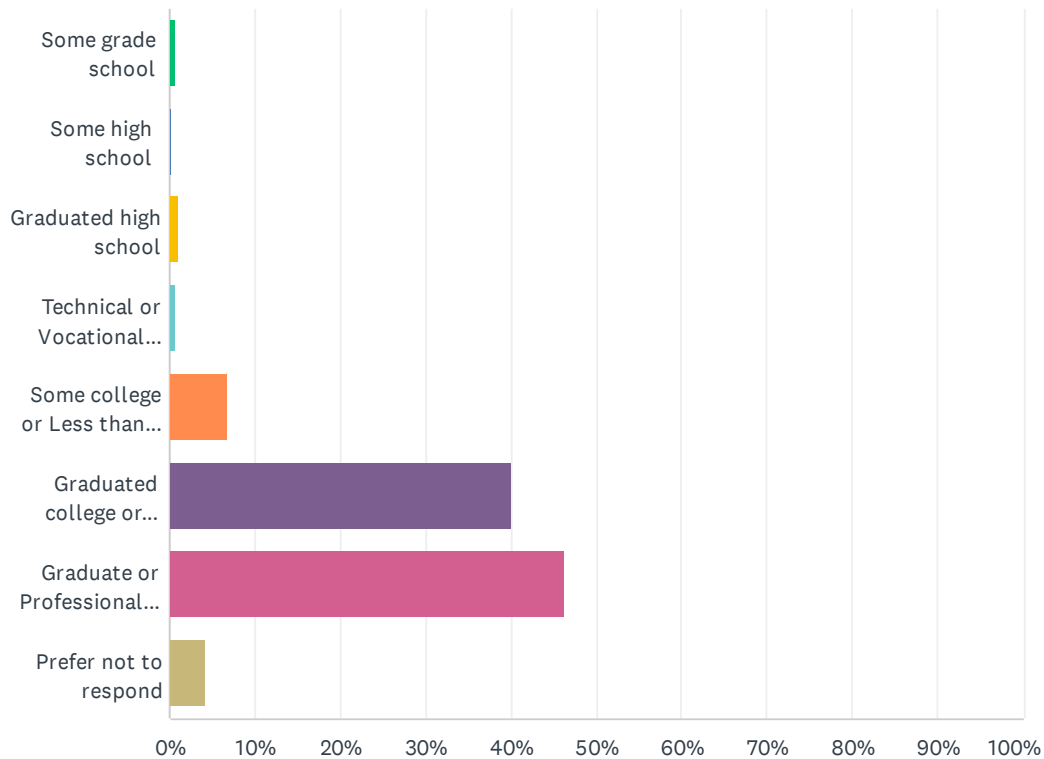

Q21 What is the highest level of education you completed in school?

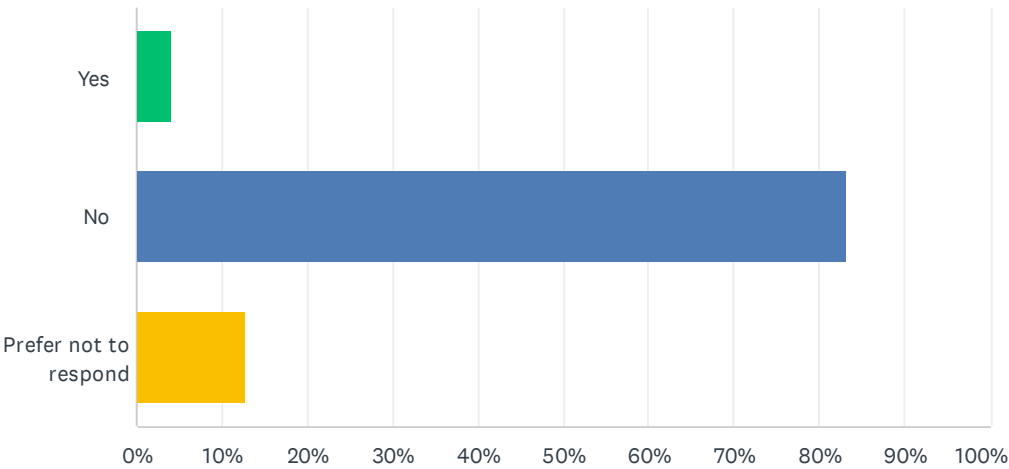

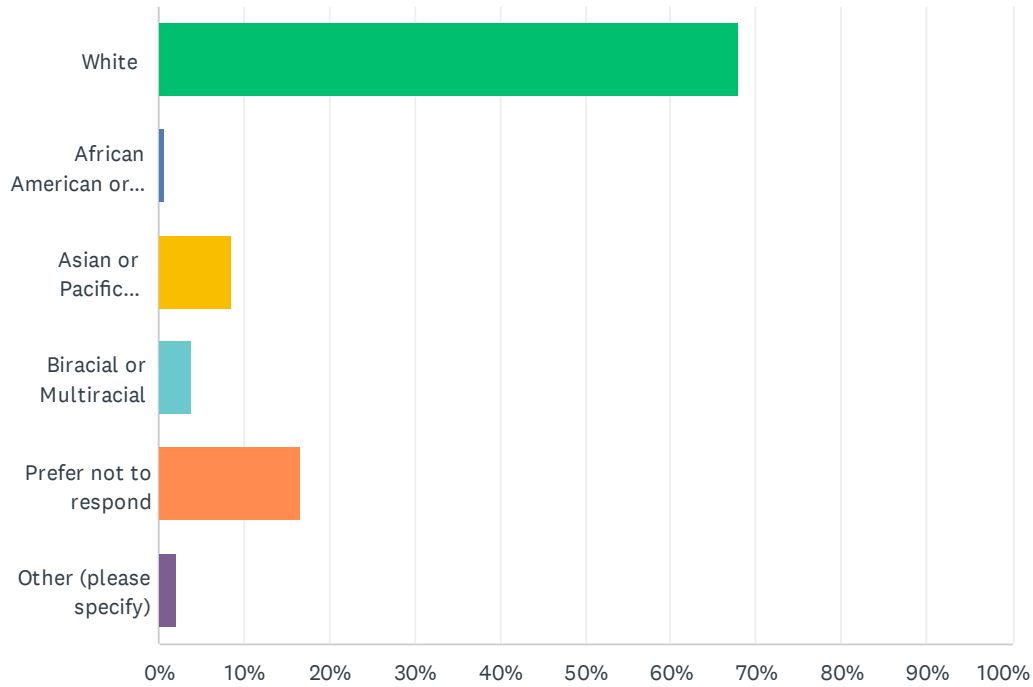
