**Applicant:** Juan Garcini, Baylis Architects

**Project description:** Construction of a 4-story mixed use development. Proposal includes 26 residential units with 3,396 square feet of retail space. Parking will be located within the structure at grade and below grade.

This project was approved with conditions by the Design Review Board on May 21, 2025.

Affected property owners may request a change in valuation for property tax purposes notwithstanding any program of revaluation.

**How to Appeal:**

*Only the applicant or those persons who previously submitted written or oral testimony or comments to the Design Review Board are entitled to appeal this decision. Only those persons who file an appeal, the applicant, and the Design Review Board Chair (or designee) may participate in the appeal hearing.* The appeal must be in the form of a letter of appeal and must be delivered, along with any fees set by ordinance, to the Planning and Building Department by 5:00 PM, June 5, 2025. For information about how to appeal, contact the Planning and Building Department at 425-587-3600. An appeal of this project decision would be heard by the Hearing Examiner.
