**Project Description:** The project is needed to close gaps on several segments of the city's sidewalks in two locations. The first project location constructs sidewalks and associated improvements like curb and gutter, driveways, and drainage infrastructure on the east side of 6<sup>th</sup> St W, between 11<sup>th</sup> Ave W and Market St. The second project location constructs sidewalk, a water main extension, and associated improvements on the north side of Kirkland Way, between 2<sup>nd</sup> Ave and 9<sup>th</sup> St. This project will include work on a catch basin within a piped stream along Kirkland Way.

Lead agency is the City of Kirkland

The lead agency for this proposal has determined that it does not have a probable significant adverse impact on the environment. An environmental impact statement (EIS) is not required under RCW 43.21.030(2)(c). This decision was made after review of a completed environmental checklist and other information on file with the lead agency. This information is available to the public upon request.
