



# City of Kirkland Notice of Application And Optional SEPA notice

Park Heights Short Plat, Case No. <u>SUB25-00184</u>, <u>SEP25-00776</u>, <u>SAR25-00775</u>

**Proposal:** Robby Overfield with ESM Consulting Engineers LLC, the applicant, is requesting a Subdivision Process I Permit to divide one 149,718 SF (3.44 acre) parcel into 9 parcels of 7,644 SF, 7,621 SF, 9,558 SF, 9,688 SF, 9,157 SF, 11,463 SF, 8,723 SF, 9,037 SF, and 11,667 SF in the RSA 4 Zone. The parcel to be divided will first be modified through a lot line alteration. This project includes a wetland buffer averaging proposal and requires SEPA review. The application was received by the City on March 13, 2025 and was deemed complete on October 20, 2025.

Neighborhood: Finn Hill

**Review Process:** The decision on this application will be made by the Director of Planning and Building. Prior to the decision, there is an opportunity for the public to submit written comments, as described below. The Planning and Building Director will also receive a report from the Planning and Building Department staff making a recommendation on the application. The decision will be based on whether the application complies with Kirkland's Subdivision code and other applicable codes.

**Environmental Review**: The City of Kirkland is requesting input per WAC 197-11-335 prior to making a SEPA threshold decision. This process integrates the comment period for the Notice of Application and provides for early comment regarding SEPA.

Agencies, tribes and the public are encouraged to review and comment on the proposed project and its probable environmental impacts. Comments must be submitted by **December 1**, **2025** (**REVISED**) to Priya Vellaipandian.

In the event that mitigation measures are proposed after the close of the integrated comment period, notice shall be given as required in KMC 24.02.160. the DNS or MDNS will not be issued until the comment period is over. A copy of the DNS or MDNS for the proposal stating the time period for filing an appeal may be obtained upon request.

Public Comment: Comments may be provided in writing only. To be considered, written comments must be received prior to 5:00 PM on <a href="December 1, 2025 (REVISED">December 1, 2025 (REVISED</a>). Send written comments to project planner, Priya Vellaipandian, 123 Fifth Avenue, Kirkland, WA 98033 or to e-mail pvellaipandian@kirklandwa.gov. Please indicate your name, mailing address, e-mail address and refer to permit number SUB25-00184. A copy of the Planning and Building Director's decision will be mailed to those providing written comments before the comment deadline. Others may obtain copies from the Planning and Building Department.

APPEALS: The Planning and Building Director's decision may be appealed to the Hearing Examiner only by the applicant or those who submitted written comments by the comment deadline. Additional information about how to appeal will appear in the staff report and Planning and Building Director's decision.
