Proposal: Moira Haughian with Legacy Group Capital, the applicant, is requesting a Subdivision Permit to divide one 130,827 SF parcel into 6 parcels of 12,500 SF, 12,508 SF, 12,510 SF, 11,250 SF, 14,051, and 14,428 SF in the WD II Zone. The application was received by the City on August 26, 2025 and was deemed complete on September 30, 2025.

Location: 713 13TH AVE W

Neighborhood: Market

Review Process: The decision on this application will be made by the Director of Planning and Building. Prior to the decision, there is an opportunity for the public to submit written comments, as described below. The Planning and Building Director will also receive a report from the Planning and Building Department staff making a recommendation on the application. The decision will be based on whether the application complies with Kirkland's Subdivision Code and other applicable codes.

Environmental Review: The City of Kirkland has reviewed the proposal for probable adverse environmental impacts and expects to issue a determination of non-significance (DNS) for this project. The optional DNS process in WAC 197-11-355 and KMC 24.02.170 is being used. This process integrates the comment period for the Notice of Application and SEPA. **This may be the only opportunity to comment on the environmental impacts of the proposal.**

Agencies, tribes and the public are encouraged to review and comment on the proposed project and its probable environmental impacts. Comments must be submitted by November 10, 2025 to Priya Vellaipandian.

In the event that mitigation measures are proposed after the close of the integrated comment period, notice shall be given as required in KMC 24.02.160. the DNS or MDNS will not be issued until the comment period is over. A copy of the DNS or MDNS for the proposal stating the time period for filing an appeal may be obtained upon request.

Public Comment: Comments may be provided in writing only. To be considered, written comments must be received prior to 5:00 PM on November 10, 2025. Send written comments to project planner, Priya Vellaipandian, 123 Fifth Avenue, Kirkland, WA 98033 or to e-mail PVellaipandian@kirklandwa.gov. Please indicate your name, mailing address, e-mail address and refer to permit number SUB25-00632, SHR25-00633 & SEP25-00677. A copy of the Planning and Building Director's decision will be mailed to those providing written comments before the comment deadline. Others may obtain copies from the Planning and Building Department.

APPEALS: The Planning and Building Director's decision may be appealed to the Hearing Examiner only by the applicant or those who submitted written comments by the comment deadline. Additional information about how to appeal will appear in the staff report and Planning and Building Director's decision.
