## G3HLK ULS, Case No. SUB25-00781

**Proposal:** Christine Dickinson, the applicant, is requesting a Process I Permit to divide one 8,888 SF parcel into 2 unit lots of 6,645 SF, and 2,243 SF in the RS 7.2 Zone. The application was received by the City on October 20, 2025, and was deemed complete on November 5, 2025.

Location: 317 & 319 18th Ave

**Neighborhood: Norkirk** 

**Review Process:** The decision on this application will be made by the Director of Planning and Building. Prior to the decision, there is an opportunity for the public to submit written comments, as described below. The Planning and Building Director will also receive a report from the Planning and Building Department staff making a recommendation on the application. The decision will be based on whether the application complies with Kirkland's Zoning Code and other applicable codes.

Public Comment: Comments may be provided in writing only. To be considered, written comments must be received prior to 5:00 PM on December 1, 2025.
