Proposal: Christine Dickinson with Chadwick & Winters, the applicant, is requesting a Subdivision Process I Permit to divide one 8,281 SF parcel into 2 parcels of 2,376 SF, and 5,905 SF in the RS 7.2 Zone. Neighborhood: Everest

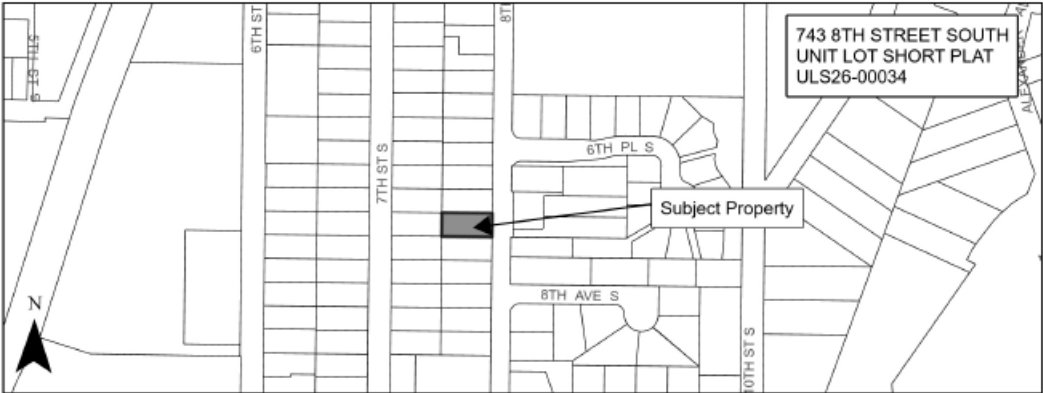
Review Process: The decision on this application will be made by the Director of Planning and Building. Prior to the decision, there is an opportunity for the public to submit written comments, as described below. The Planning and Building Director will also receive a report from the Planning and Building Department staff making a recommendation on the application. The decision will be based on whether the application complies with Kirkland’s Subdivision Code and other applicable codes.

APPEALS: *The Planning and Building Director’s decision may be appealed to the Hearing Examiner only by the applicant or those who submitted written comments by the comment deadline.* Additional information about how to appeal will appear in the staff report and Planning and Building Director’s decision.
