Proposal: Andy Marshal with Cordillera Group, the applicant, is requesting a Subdivision Process I Permit to Unit Lot Subdivide a 7,961 SF parcel into 2 unit lots, 4,591 SF and 3,370 SF, in the RS 8.5 Zone.
