Proposal: Jake Drake, DGR Development, the applicant, is requesting a Process I Unit Lot Subdivision to unit-lot subdivide one 8,398 SF parcel into 2 unit lots of 6,490 SF, and 1,908 SF in the RSX 7.2 Zone. The application was received by the City on July 28, 2026, and was deemed complete on August 17, 2026.

Review Process: The decision on this application will be made by the Director of Planning and Building. Prior to the decision, there is an opportunity for the public to submit written comments, as described below. The Planning and Building Director will also receive a report from the Planning and Building Department staff making a recommendation on the application. The decision will be based on whether the application complies with Kirkland's Subdivision Code and other applicable codes.
