

City seeks feedback on 100th Ave. NE crosswalk

Transportation staff is seeking community feedback on a proposed crossing at Northeast 140th Street

WHAT: The City is inviting community members to a Dec. 5 virtual meeting to discuss a new resident-requested pedestrian crossing at 100th Avenue Northeast's intersection with Northeast 140th Street.

The one-hour Zoom meeting begins at 6:30 p.m.

The proposed crosswalk would include a pedestrian refuge island and Rectangular Rapid Flashing Beacons.

The new crosswalk will prevent drivers from turning west onto Northeast 140th Street from northbound 100th Avenue Northeast. It will, however, allow westbound drivers to turn left onto southbound 100th Avenue Northeast from Northeast 140th Street.

The crosswalk is not currently a part of the 100th Avenue Northeast improvements project. Residents, however, have expressed a

desire for a Northeast 140th Street crossing to add better east-west pedestrian access along the corridor.

WHEN: The Zoom meeting begins promptly at 6:30 p.m.

WHAT TO EXPECT: The meeting will include a presentation delivered by transportation division staff and will be followed by a facilitated discussion.

Progress continues on 100th Ave. NE

A Kirkland contractor is continuing to make significant progress on a series of ambitious improvements that will transform the 100th Avenue Northeast corridor into a safer, more efficient and more pleasant arterial for all traveling modes, including walking, bicycling, riding transit and driving.

OMA Construction is building separated sidewalks and elevated bicycle lanes along both sides of the corridor, between Northeast 139th and 145th streets. To improve traffic flow, the contractor is also creating two more automotive lanes and optimizing 100th Avenue Northeast's intersections with Northeast 139th, 145th streets and Simonds Road.

WHEN: OMA Construction is working eight hours a day between 7 a.m. and 4 p.m., Monday through Friday. OMA Construction plans to complete the project in spring 2025.

- The work requires some intermittent lane-closures; however, the road will be open to walking, bicycling and driving at all times.
- The speed-limit is 25 miles per hour during construction.

PUGET SOUND ENERGY: Previously, Puget Sound Energy worked nights to relocate its gas lines along the corridor.

The gas line relocation created space for OMA Construction to implement the 100th Avenue Northeast improvements.

Puget Sound Energy's crews will return to the corridor at a later date to remove unused utility poles after telecommunications utilities have been moved to the new poles.

Juanita Drive work begins spring 2024

Kirkland's staff and consulting engineers plan to begin construction in spring 2024 on a series of improvements along Juanita Drive Northeast.

The improvements include a buffered bicycle lane and sidewalk between Northeast 120th and 132nd streets, a new turn lane at Northeast 120th Street, a set of rapid flashing beacons at Northeast 124th Street and intersection improvements at Northeast 128th and 132nd streets. The City has postponed improvements at Northeast 112th Street.
