Site 3: Stormwater Treatment Vaults and Infiltration Wells Located on NE 149TH ST north of intersection with 124TH AVE NE

Description

This project would install six water quality treatment vaults and six stormwater infiltration wells to help slow the flow and clean polluted runoff before it reaches Juanita Creek.

This project would receive rainwater runoff from approximately 110 acres of upstream area.

wildlife and recreation

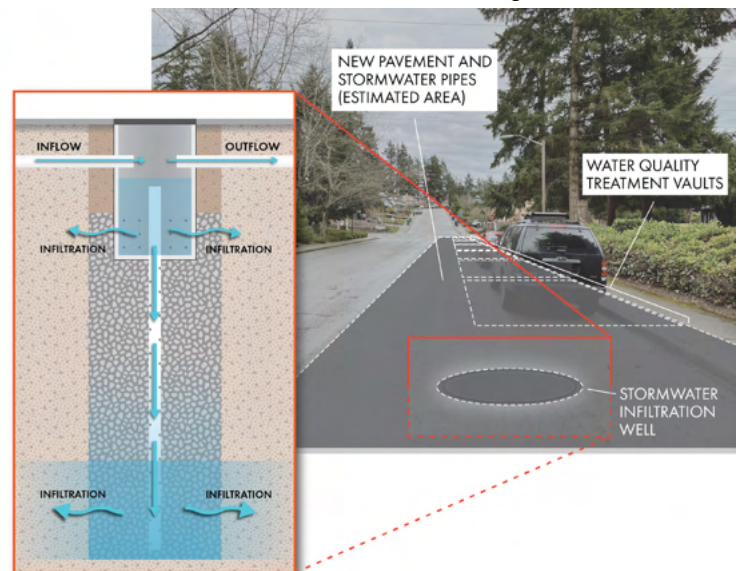

Site 3: Stormwater Treatment Vaults and Infiltration Wells

Located on NE 149TH ST north of intersection with 124TH AVE NE



Design Elements

- Install water quality treatment vaults to filter water before it flows to Juanita Creek.
- Install deep infiltration wells to help rainwater runoff soak into the ground.
- Construct new stormwater pipes and repair pavement.

Potential Benefits

- Improve water quality in Juanita Creek and provide flow control to reduce downstream flooding.
- New pavement for a smoother surface in the street.

Potential Impacts

- All work will take place in/under public streets.
- Neighborhood access impacts during construction.
- Noise associated with construction activities.

What's Next?

No construction will take place for at least 2-5 years. With your input, the City will select the top three locations from the four potential locations above. Once the top three projects are selected, we will develop initial designs and will seek your input to refine each project. We would also need to secure funding before moving to construction.
