Transition Plan

Introduction

The Americans with Disabilities Act (ADA) requires all public services, policies and practices to be compliant as outlined in Title II. The City of Kirkland has established a Pathway to Transition document that summarizes the Title II ADA compliance requirements, outlines the actions needed to meet those requirements and contains assessment results. For those services, programs and activities that were identified as not being in compliance, the City is required to prepare a Transition Plan for structural improvements, as well as correct deficiencies for those services, programs and activities that are not a structural improvements. The Transition Plan illustrates how and when the City plans to correct identified deficiencies. The Transition Plan, in draft format, will be posted on the City's website (www.kirklandwa.gov) for public review and comments. The Transition Plan is a living document, which will be updated annually.

Below is the definition of a Transition Plan from the Americans with Disabilities Act Title II Regulations Part 35- Nondiscrimination on the Basis of Disability in State and Local Government Services.

Transition Plan

If a public entity has responsibility or authority over streets, roads, or walkways, its transition plan shall include a schedule for providing curb ramps or other sloped areas where pedestrians walks cross curbs, giving priority to walkways serving entities covered by the ACT, including State and local government offices and facilities, transportation, places of public accommodation, and employers, followed by walkways serving other areas.

The plan shall, at a minimum –

- Identify physical obstacles in the public entity's facilities that limit the accessibility of its programs or activities to individuals with disabilities
- Describe in detail the methods that will be used to make the facilities accessible

- Specify the schedule for taking the steps necessary to achieve compliance with this section and, if the time period of the transition plan is longer than one year, identify steps that will be taken during each year of the transition period
- Indicate the official responsible for implementation of the plan (Title II ADA 35.150)

The Transition Plan lists each area needing correction along with costs, methods/steps to make them accessible, correction schedule and responsible party. As areas are brought into compliance, items will move out of the Transition Plan and the corrections recorded in the Pathway to Transition document.

Facilities

The City of Kirkland completed an assessment of all City Facilities in 2014. This assessment was completed by Facilities maintenance staff using criteria using criteria for accessible pathways, building access and parking.

Curb Ramps

The Public Works department has proposed to address corrections to 80 curb ramps per year through 2058 at a total estimated cost of \$14.8 million dollars. These repairs will come through overlay projects, capital improvement projects and development. The locations will be assigned as projects are identified.

Website

The Information Technology department completed a strategic plan in 2018. This strategic plan allocates \$200,000 in 2019 to provide funding for a city website replacement where ADA compliancy is a primary requirement.
