Subject: Attain Housing: Addressing Homelessness for 30 Years

RECOMMENDATION:

That the Human Services Commission hear a presentation from Attain Housing's Executive Director, Kathy Fleming.

BACKGROUND:

Attain Housing has provided transitional housing and case management to families experiencing homelessness for 30 years.

Other programs include:

- Stable Home: this program prevents individuals and families from falling into homelessness by providing flexible funds for avoiding evictions and for move-in expenses when deposits and down-payments are the only thing between homelessness and being housed.
- Weekly Community Supper: With the generous assistance of community members, Attain hosts a weekly Community Supper for 35-50 individuals at Holy Spirit Lutheran Church in Kirkland
- Adopt-a-family Holiday programs for local families

You will have the opportunity learn about the history of this local agency, the changes and challenges the agency has faced and what the agency has learned about what is needed to house people and keep them housed.

Subject: Review of 2019-2020 Human Services Priorities

RECOMMENDATION:

BACKGROUND:

In preparation for the upcoming 2021-2022 human services grant application process, staff would like to get feedback from Commissioners about the priorities it established for the 2019-2020 grant process.
