RECOMMENDATION:

That the Human Services Commission hear a presentation from a representative of the King County Alliance of Human Services.

BACKGROUND:

Jerry Kroon, Executive Director of the Eastside Legal Assistance Program, requested the opportunity to speak to the Commission about the KCAHS campaign to increase city investments in human services programs.

The KCAHS was created when a group of non-profit human services agencies came together to respond to the cuts to human services made by King County. This alliance committed to increasing the County's investments through advocacy for a series of tax measures through the electoral process. These efforts resulted in MIDD Behavioral Health Sales Tax Fund, the Veterans, Seniors & Human Services Levy and Best Starts for Kids initiative. After reaching its goal for King County funding, it has turned its attention to advocating for increased investments by cities in King County.

Subject: Debrief Session

RECOMMENDATION:

That the Human Services Commission discuss the learnings from the provider panels of 2019 and the September 17th joint Human Services Commission meeting.

BACKGROUND:

Over the last several months, the Human Services Commission has heard from panelists discussing the following topics:

- On the Frontline: First Responders Serving Community Members Experiencing Homelessness and/or with Behavioral Health Challenges
- Hopelink & The Role of Community Action Agencies
- Domestic Violence: Services and Needs in the Community
- Imagine Housing Staff and Resident Panel: Resident Challenges

In addition, members of the Human Services Commissions of Bellevue, Issaquah, Kirkland, Redmond and Sammamish met together on Tuesday, September 17 at Bellevue City Hall to explore ways to make the human services grant application process more equitable. City staff shared their efforts to gather feedback from people of color-led agencies who have applied for funding in the past as well as those who have not applied. Rainier Valley Corps Executive Director Vu Le shared his own experiences as an ED and those he has worked with in this area.

City staff would like to gather the Human Services Commission main takeaways from these educational opportunities and ascertain how this information might inform the 2021-2022 human services grant application process. Finally, city staff would like to review the remaining planned panels to ensure they still meet their needs.
