Subject: Park Board Training

RECOMMENDATION

That Park Board receive training on the role of Park Board; the Parks, Recreation, and Open Space (PROS) Plan; and Robert's Rules of Order.

BACKGROUND DISCUSSION

Staff have prepared several presentations that will be used as a part of the orientation process of new Board members in the future. With several new Park Board members appointed this year, staff recognized the brief orientation provided did not adequately prepare new members for the breadth of information discussed by the Board. In the future, detailed training and orientation will be provided when new Board members are appointed. Conducting the training for all Board members at this time will ensure all members are on the same page and have the knowledge needed to serve on the Board.

Staff will provide training on the role of the Park Board; the Parks, Recreation, and Open Space (PROS) Plan; and Robert's Rules of Order and meeting facilitation. These training presentations will provide a greater background on Park Board and will inform Board members about the operations of the Parks and Community Services Department, laying the groundwork for future discussions. Additional training topics, which will be provided in the future, include Parks and Community Services funding and service levels and the park planning and design process.

Subject: Election of Chair and Vice-Chair

RECOMMENDATION

That the Park Board conduct elections to fill the positions of Chair and Vice-Chair for 2020.

BACKGROUND DISCUSSION

Kirkland Municipal Code 3.36.040 states that the Park Board Chair and Vice-Chair will be elected annually to a one-year term and elections will be held at the Board's final meeting of the year. The Chair may be re-elected once to serve a maximum of two years; the current Chair, Rosalie Wessels, will have served two years as Chair as of the Board's December meeting. No such term restriction is applied to the position of Vice-Chair.

The Chair is responsible for presiding over Park Board meetings. The Chair may be called on to attend other meetings with City Council, the community, or staff. The Vice-Chair is responsible for performing the duties of the Chair in the event the Chair is not present. Should the Chair be unable to complete their term, the Vice-Chair will assume the Chair position for the remainder of the year. The Chair and Vice-Chair may be asked to represent the Park Board by speaking at events, such as park dedication ceremonies or naming events. The Chair and Vice-Chair meet with Parks and Community Services staff to discuss issues and to assist in setting the agenda for upcoming meetings.

In preparation for this election, staff sought and received feedback from Park Board members about the skills and abilities needed in the next Chair and Vice-Chair. Common responses include the following:

Strong organizational skills

Meeting facilitation skills

Time management/keeping discussions on topic

Finding a balance between ensuring everyone has a chance to speak yet ensuring discussions do not drag on unnecessarily

Ability to interpret and understand the thoughts and feelings of other Board members Knowledge of department When thinking about the upcoming election, Board members should consider the demands of the position in addition to the identified skills and abilities. Board members should think about who possesses these skills and abilities, and who would make a good Chair/Vice-Chair.

The Chair will conduct the election process. During the election process, any Board member may nominate any other Board member, including themselves, for the position being elected. Nominations do not need to be seconded by another Board member, however, a nominee may decline the nomination if desired.

Staff recommend Park Board follow the process outlined below for elections.

- 1. Conduct the election for the Chair position first, followed by the Vice-Chair position.
- 2. The Chair begins the election procedure by calling for nominations for the open position being considered.
- 3. Once all nominations have been made, the Chair closes the nomination period and gives each nominee the opportunity to speak toward their desire for the position.
- 4. Once each nominee (who has accepted the nomination) has been given the chance to speak, the Chair shall ask the Recording Secretary to call the vote.
- 5. The election will be conducted via roll call vote, in which the Recording Secretary will call on each Board member to announce their vote. The Recording Secretary will repeat the vote to ensure accuracy.
- 6. The nominee with the most votes will be declared the winner.
- 7. In the event of a tie, the voting process will be repeated with the tied nominees until there is no longer a tie. The Chair may choose to provide a second opportunity for the tied nominees to speak toward their desire for the position.

The new Chair/Vice-Chair will assume these positions following the adjournment of the December Park Board meeting.


HUMAN SERVICES COMMISSION RESIGNATION


USING SOCIAL MEDIA TO CONNECT






FIRST PICKLEBALL LEAGUE WRAP-UP

PARKS MANAGEMENT

NEW FUNDING OPPORTUNITY

King County Councilmembers Balducci and Dembowski have verbally committed to providing grant funding in 2020 (via King County WaterWorks Council Allocated Funding) to support additional habitat restoration along Juanita Creek and an increase in volunteer events with Eastside Prep at Watershed Park!



WASHINGTON CONSERVATION CORPS

The Green Kirkland Partnership has historically hired Washington Conservation Corps (WCC) crews for a few weeks each year to focus on restoration work not suitable for volunteers. This year, thanks to increased funding levels and partnerships, we were able to contract for a year-round crew. The crew works October 2019 through September 2020.

Earlier this month the Lake Stevens WCC crew joined Kirkland's WCC Crew for a joint day in the field at Watershed Park. Working together, the "super crew" focused on ivy removal and infill planting. The super crew days are when another WCC crew comes to our park to team up on a project. Our crew returns the favor by traveling to one of their sites at a later day/time to help with one of their projects. It is fun for the crews, allows them to learn

from one another, and allows them to tackle big projects that benefit from having up to 12 people in the field working together.

UPDATES

This time of year, staff focus on preparing for the winter season in a variety of ways.

Staff are removing, recycling, and mulching leaves throughout the park system. Recent rains and cold weather helped encourage the trees to drop their remaining leaves. We are hopeful to be done with the process soon!

Restrooms and irrigation systems were winterized this past month. Honeybuckets were placed at high-use parks for the winter season.

Staff applied de-icer several times this month and will continue to do so as the conditions demand.

Staff continue with their Fall tree plantings. Lots of great specimens and park locations receiving new trees.

Lots of small little projects happening out in the system. Small electrical, plumbing, power-washing, and prep work to keep the infrastructure in good order.



Unfortunately, we were the recipients of an abnormal amount of vandalism at some of our parks this past month. South Rose Hill, Edith Moulton, OO Denny, Peter Kirk, and 132nd were all "tagged" this month. Staff worked to address and correct the damage as quickly as possible to discourage this type of activity.

PARKS MAINTENANCE CENTER CONSTRUCTION

The new Parks Maintenance Center is nearly complete. Lots of preparation around the shop in anticipation of the big move scheduled for early December. Boxes are being packed and a thorough "house-cleaning" is underway. Please join us for the ribbon-cutting ceremony at the new facility on Monday, December 9, 2019, at 12 pm.

PARK PLANNING AND DEVELOPMENT

JUANITA BEACH BATHHOUSE RENOVATION


Six bids were received on November 15, 2019. The lowest bid came from Synergy, Inc., a construction company out of Woodinville. The contract award is expected to be approved at the December 10, 2019, City Council meeting with construction anticipated to begin in January. There will be a groundbreaking event sometime in January.

Background of Project: This is phase II of the Juanita Beach Park development project. This phase includes replacing the bathhouse, adding two new picnic shelters and installing an all-inclusive new playground. Numerous environmental improvements will occur throughout the park.

132ND SQUARE PARK

Scope and funding options were presented to City Council on November 6, 2019. The Council voted to fund the entire Master Plan estimated at \$5.7M. A 30% design review with the public and Park Board will occur sometime in mid-February.

Background of Project: The City is replacing a non-regulation grass sports field with a synthetic turf field after the installation of a surface water detention structure underneath the field.



DAVID BRINK PARK SHORELINE RENOVATION

30% design drawings are complete. The design will be shared on the project's webpage and the Park Board sometime during the first part of the year after additional CIP funding is approved in December.

Background of Project: This is part of a larger shoreline infrastructure project conducting major maintenance of docks, piers and shorelines.

CITY/SCHOOL PLAYFIELD PARTNERSHIP

Finn Hill Middle School playfield has been renovated and will be available for play spring 2020.

Background of Project: This long-standing partnership will continue with the improvement of Peter Kirk Elementary School fields.

JUANITA HEIGHTS TRAIL PROJECT

Staff continue to explore trail options.

Background of Project: The expanding Juanita Heights Park is envisioned to allow trail connections to the surrounding neighborhoods all the way down to Juanita Bay Park.

PARK PLAY AREAS AND ACCESSIBILITY ENHANCEMENTS

This fall, outdoor exercise equipment was replaced at Crestwoods Park and will be added to Peter Kirk Park.

Background of Project: This ongoing capital project strives to replace aging playgrounds, improve sports courts in the parks, and improve accessibility throughout the park system.

TOTEM LAKE PARK

Bidding for this project is anticipated in January with construction beginning in March, pending bid results. There will be a groundbreaking event sometime in March.

Background of Project: With the acquisition of a parcel adjoining Totem Lake Park, the City will create a new neighborhood park. The park will include pathways, an inclusive playground, restrooms, scenic view locations, environmental restoration and a boardwalk connecting the park through the eastern side of the lake property to the Cross Kirkland Corridor.

WAVERLY PARK PHASE 2

There are no current updates.

Background of Project: The Waverly Park development will continue with additional phases. Phase II will include various improvements to the pier, walkways and accessibility of the site.
